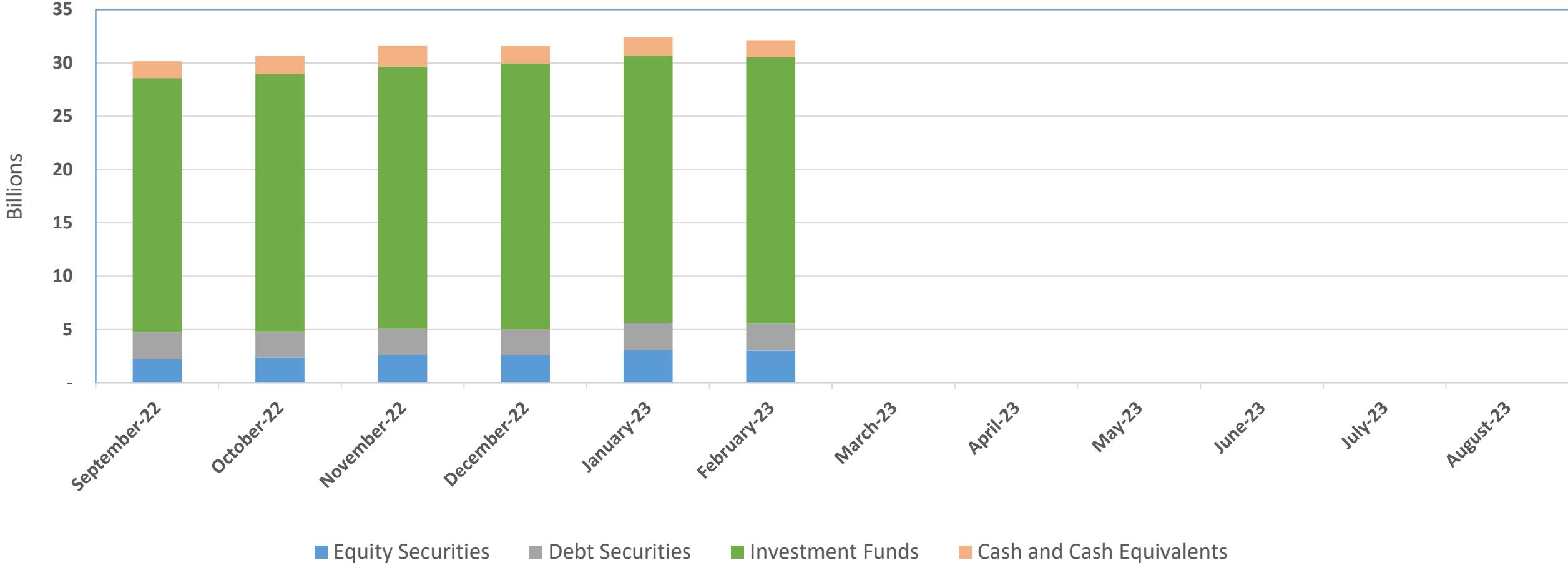


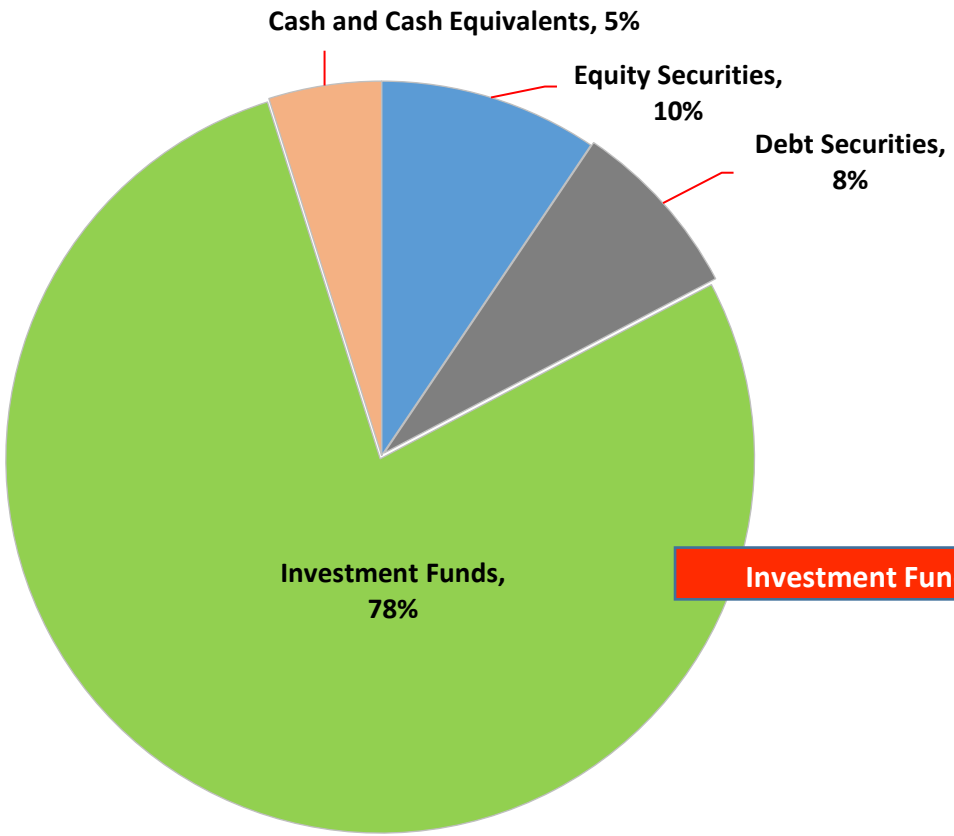

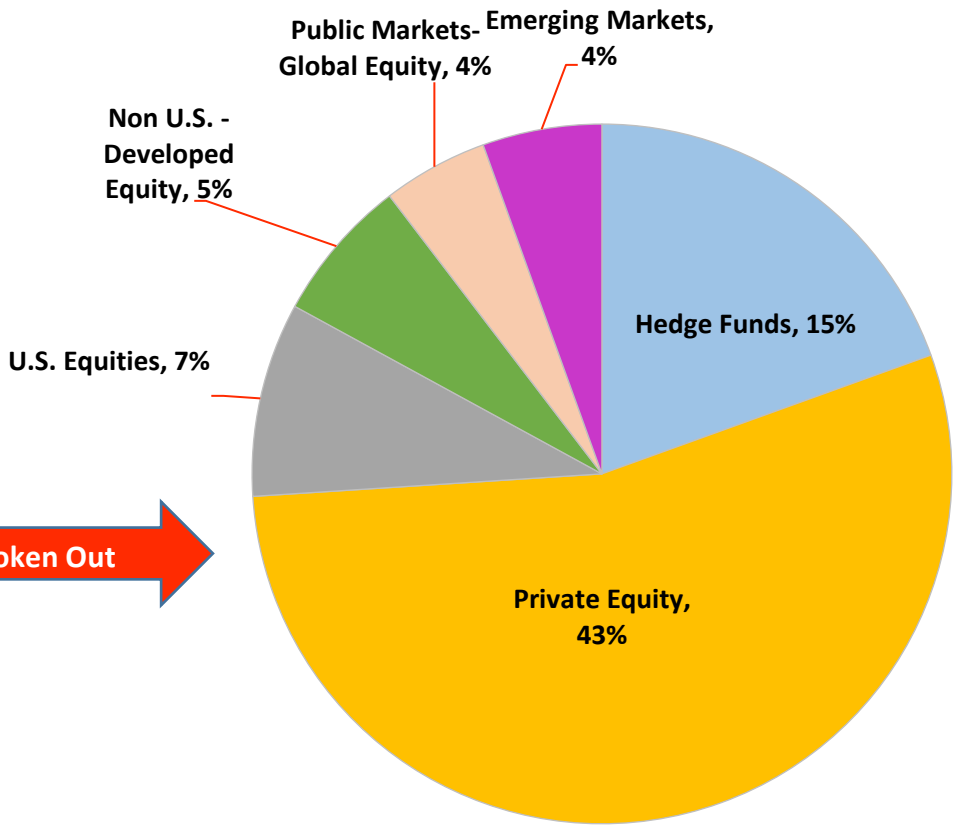
Investment Portfolio - FY 2023



Investment Portfolio as of February 2023

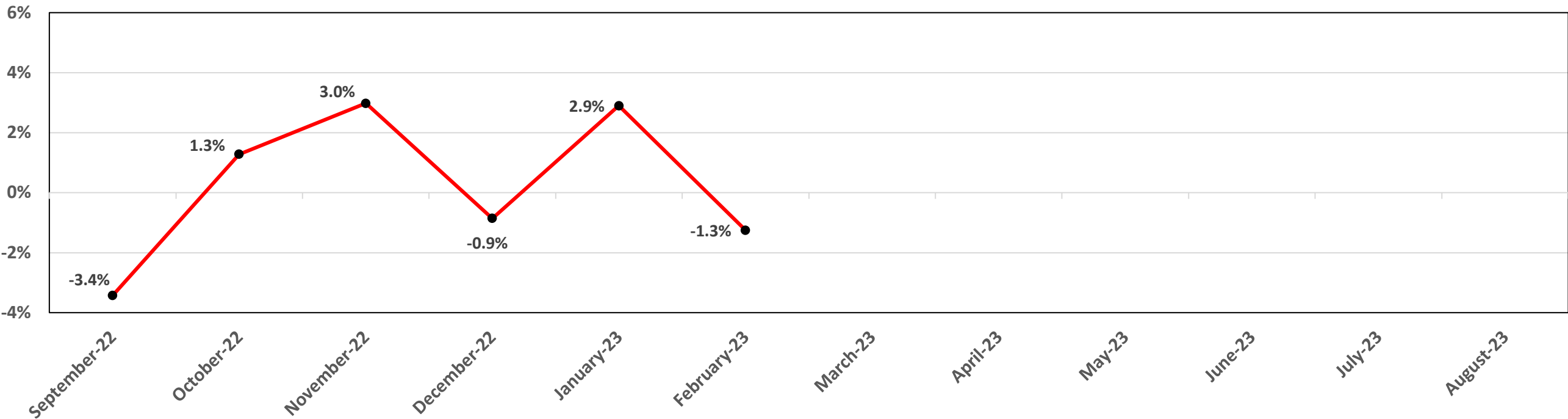


Investment Funds Breakout
