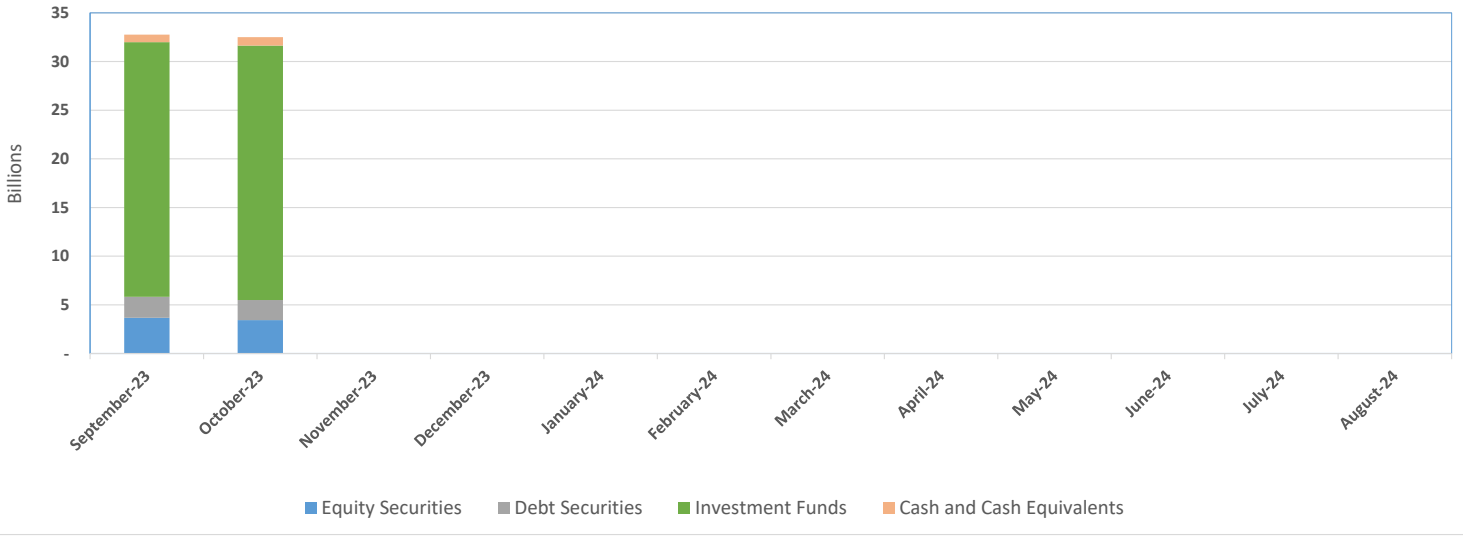


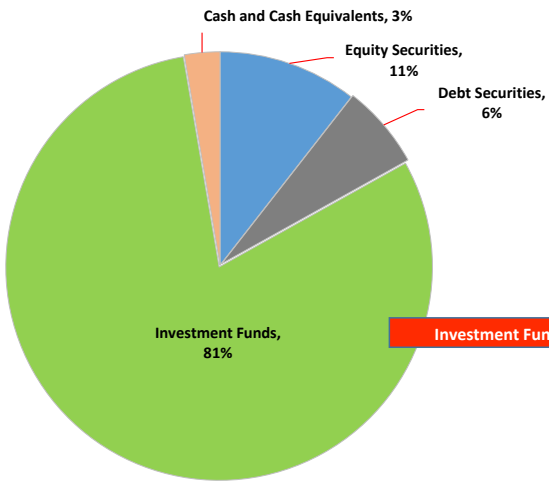

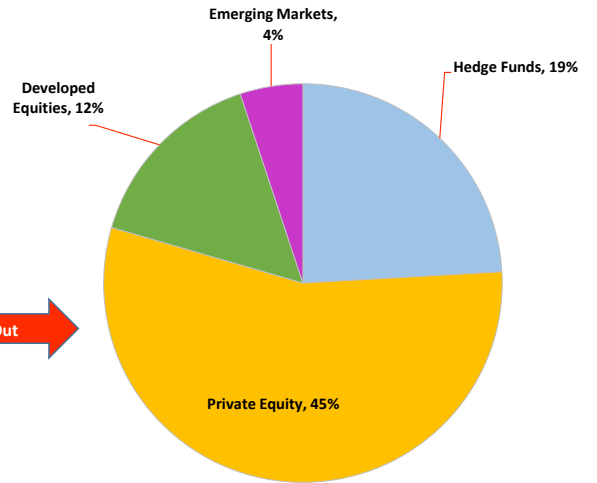
### Investment Portfolio - FY 2024



### Investment Portfolio as of October 2023

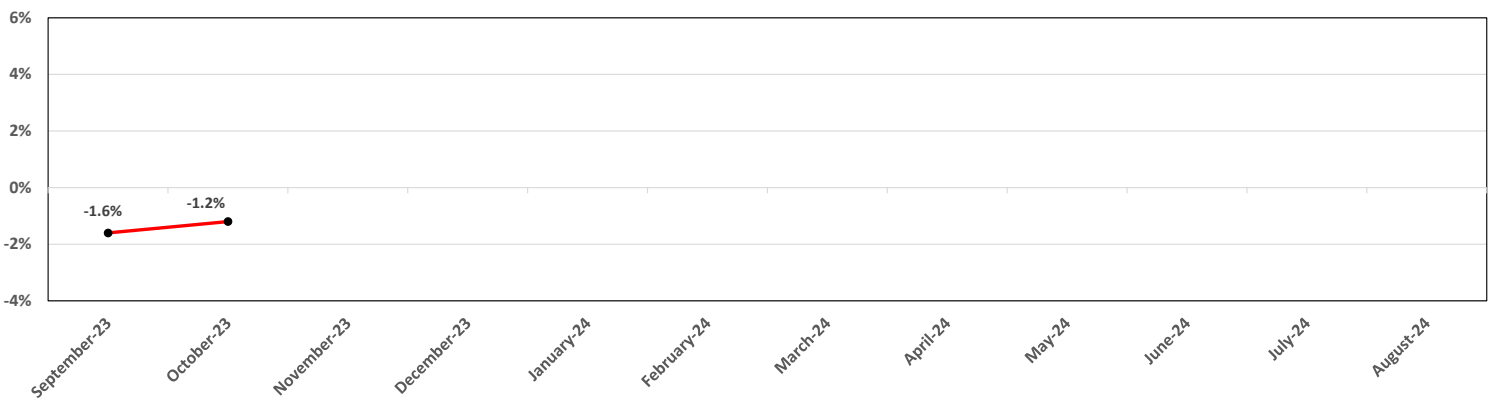


### Investment Funds Breakout
