TCHATT – Key Accomplishments

- Staff hired at BCM, Dell, TTUHSC EP, UTHSCH, UTHSCT, UTMB, UTRGV
- **Dell:** ISD Recruitment Collateral (emails, flyers, presentation slides) created & distributed. ISD recruitment underway; 8 ISD meetings completed to date.
- **TTUHSC:** Completed screening process documentation, assessment tool, crisis protocol, medicine prescribing protocol, operational procedures.
- TTUHSC EP: Training curriculum for school staff completed, essential TCHATT forms & templates developed, service delivery process map completed, resource database for referrals developed, target schools identified & contact made with some school districts.
- UTHSCH: Presentation developed along with MOU for ISDs to present to internal stakeholders.
- UTHSCSA: MOUs signed with 2 school districts and another 3 pending.
- **UTHSCT:** Target schools identified & sent information on the project. Worked with SUPERNet to make additional connections to ISDs via SUPERNet meetings.
- **UTMB:** Service delivery process map completed. Signed MOU 1 with 1 school district and meeting held with 1 other.

CPAN – Key Accomplishments

- Staff hired at BCM, Dell, TTUHSC EP, UTHSCH, UTHSCSA, UTMB, UTRGV, UTSW
- **Dell:** Contacted 1,300 PCPs, covering 13 counties. 30 clinics received in-person visit. 39 PCPs have been pre-enrolled. Intake forms, workflow and dashboard developed and shared with TCMHCC. 4 Continuing Medical Education forums completed to support PCP education.
- **TTUHSC:** Initial meetings held with local and regional umbrella organizations to discuss program.
- **TTUHSC EP:** Mental health resource database completed. Training for staff completed. Training modules developed for PCPs on ADHD, Depression and Anxiety. Completed visits to FQHC that covers three counties.
- **UTHSCH:** Developed a database of PCPs/CHCs who are co-located with TCHATT ISDs, LMHAs, with whom the institution has an established working relationship.
- **UTMB:** Developed an enrollment form for PCPs. Presented to PCPs in Beaumont.
- UTRGV: Developed extensive listing of local pediatricians and PCPs for potential enrollment.
- **UTSW**: Held internal meetings to identify business requirements for the project. Identified marketing resources for development, for outreach and education.

CPWE – Key Accomplishments

- Staff hired at TTUHSC EP, UTHSCH, UTRGV
- **TTUHSC:** Planning meetings held with LMHA, leadership, clinical staff and GME.
- **TTUHSC EP:** Contracts with all three LMHAs approved by TTUHSC legal and contracting; now working to get them signed.
- **UTHSCSA:** Contract with Center for Health Care Services (San Antonio) completed.
- **UTHSCT:** Met with the Andrews Center to review requirements, timeline and metrics. The legal team has updated the existing agreement with the Andrews Center to reflect the CPWE project; now working to get it signed.
- **UTMB:** Verbal agreement made with Gulf Coast Center to begin on September 1, 2020. Legal agreement being drafted.
- **UTGRV:** Legal agreement between UTRGV and Tropical Texas Behavioral Health out for signature. Met with Nueces Center for Mental Health and Intellectual Disabilities and Coastal Plains Community MHMR Center; working to establish legal agreements with both.



"The Texas Child Mental Health Care Consortium is established to: (1) leverage the expertise and capacity of the health-related institutions of higher education ... to address urgent mental health challenges and improve the mental health care system in this state in relation to children and adolescents; and (2) enhance the state's ability to address mental health care needs of children and adolescents through collaboration of the health-related institutions of higher education."

\$99M 86th Texas Legislature, SB 1

86th Texas Legislature, SB 11: \$99 million for the 2020-21 biennium.

- Executive Committee composed of representatives from the 13 state-funded health-related institutions of higher education in Texas as well as from HHSC, Texas Higher Education Coordinating Board, UT System, Meadows Mental Health Policy Institute, Hogg Foundation for Mental Health, and Texas Council of Community Health Centers
- Child Psychiatry Access Network (CPAN): provides telehealth-based consultation and training to pediatricians to assist them with identifying and treating mental health issues in their patients. The budget for CPAN over the bienniumis \$26 million.
- Texas Child Health Access Through Telemedicine (TCHATT) program: provides in-school behavioral telehealth care to at-risk children and adolescents. The budget is \$37 million.
- Community Psychiatry Workforce Expansion (CPWE): Providing full-time psychiatrists toserve as academic medical fellowship positions at the health-related institutions. The budget is **\$4.6 million.**
- Research program: will focus on peer reviewed health systems research, conducted collaboratively through
 networks and targeted at high priority areas affecting children and adolescents. The TCMHCC expects to spend
 up to \$10 million on these activities.
- As the Centralized Operations Support Hub (COSH), Baylor College of Medicine will: establish and manage a
 centralized communications system and a centralized data management system. UT System serves as the
 administrative support entity for the Consortium.







CHILD PSYCHIATRY ACCESS NETWORK (CPAN) AND EL PASO

Texas Tech Physicians of El Paso Psychiatry will serve as a CPAN hub and lead the way in connecting the El Paso behavioral health community with primary care providers.

CPAN will serve 16 counties, including Brewster, Crockett, Culberson, El Paso, Hudspeth, Jefferson Davis, Kinney, Loving, Maverick, Pecos, Presidio, Reeves, Terrell, Val Verde, Ward and Winkler.

What does CPAN offer for El Paso children's health care?

Teleconferencing and Telephonic Consultations

Primary care providers will be able to communicate with the CPAN program directly for timely psychiatric consultation and care coordination for assistance with referrals.

Mental Health Screening Tools

Primary care providers will have access to online mental health screening tools.


Process



Opportunities and Challenges

- New residency (moving from 3 year to 4 year as of July 2020) (6 residents/year). Community psychiatry focus.
- Limited UTRGV core faculty (3 psychiatrists)

 Tropical Texas: Volunteer faculty, but caseloads high, limited teaching time.
 High frustration level from some psychiatrists – felt neglected by UTRGV

Tropical Texas

Goal: expand resident FTE by 1 this year, and by 2 in 2020-2021 academic year

Faculty: (from CPWE) currently: Dr. Escamilla, Dr. Weisman, Dr. Gutierrez – additional faculty from Tropical.

In 2020-2021 will add additional part time faculty

Keys to Success:

1. Monthly meetings with CEO and medical director and training or and chair

2. Joint Grand Rounds with CMEs (Weslaco)

3. Opportunity for faculty within Tropical Texas

Tropical Texas Previously had .5 resident FTE Currently 4.5 FTE (!) 17 residents rotating: from one half day to over 20 hours a week Rotations include child/adolescent outpatient, first episode psychosis, emergency assessment, substance abuse, primary care

Resident Feedback (Tropical Texas)

Primary care rotations:

"good rotation, attendings provided good level of supervision, good learning experience" "very good experience" "excellent" "very good way to learn primary care in the context of psychiatry"

Child psychiatry rotations:

COSH Operations

- Laurel Williams started working in her capacity as Medical Director on March 23, 2020
- Working to get key hires for COSH
- Have Set up meetings with each HRI CPAN and TCHATT teams respectively. Have met with 10/11 teams to date.
 - Great teams hired to date!
- Have set up meeting with Sonja Gaines to discuss resources needs for CPAN and TCHATT teams respectively
 - Submeeting with another team that does resource location
- Continued bi-weekly CPAN committee meetings
- Meeting with TEA around TCHATT once schools closed

Request for Proposals COSH Process

- RFP deadline was April 3, 2020 through the BCM Procurement process
- Two team applied singly to each RFP
- BCM had approached 2 additional teams respectively for each vendor request to see if other teams would submit applications, however, these teams declined to submit
- COSH is now working to secure each vendor for a tentative go-live date for CPAN - May 7, 2020 and TCHATT May 18, 2020
- Costs:
 - Telecommunication vendor is significantly under budget based on vendor selection
 - Data Management vendor is on budget may be able to reduce costs amonst HRI for data management budget with the selection of the vendor- another cost savings potentially

Telecommunications: Lantana Communications

 - Each team does an internal launch with current numbers (not preferred)
 - BCM launches the number
 - and then routes to specific hubs
 - As hubs become live on Lantana their calls get routed to them

Data Management: Trayt

Data Management/Trayt Privacy and Security of Data is Essential

- COSH is assembling the specific teams/individuals at each HRI to jointly review the Trayt platform and their data security processes
- Trayt conforms to Hi-Trust Standards
- Trayt is able to have Multi-factor log process that is now common across many HRIs to increase security of data

Web Virtual Library and Webinars

- With the COVID challenge and schools closed our team wanted to pivot to ways TCHMCC might respond to the challenge
- Early discussions with Dr. Lakey and Co-Chairs for TCHATT indicated we could move to Telehealth in families homes for Phase 1
- We also discussed the idea for a BACK TO SCHOOL Learning Collaborative
- "Mental Health Mondays"
- We could target three teams with perhaps 3 important themes that will be important to focus on as we return to "normalcy"
 - School personnel
 - Families/Students
 - PCP

Web Virtual Library and Webinars: Brainstorm?

Ideas included:

- Adults dealing with stress and anxiety
- Recognizing trauma and how implicit bias may derail an mental health referral to the youth instead having a disciplinary referral
- How building strong relationships/communication with youth (with all adults) improves academic outcomes, mental health and resiliency
- The hope is that all HRI might be able to draw on expertise do one or more topics, get recorded and stored on the website
- COSH would help organize
