



Group Term Life Benefit for the University of Texas System's Retired Employees

Eligibility: All benefits eligible retired employees may enroll for coverage. For questions on eligibility, please refer to the Office of Employee Benefits Retired Employee Insurance webpage or contact your institution Benefits Office.

BENEFITS AT A GLANCE
Retired Employee Basic Life: \$6,000
Retired Employee Voluntary Life: You may elect one of the following options: \$7,000, \$10,000, \$25,000, \$50,000, or \$100,000
Dependent Spouse Voluntary Life: You may elect \$3,000.
Note: You must be insured for voluntary coverage above the \$6,000 basic benefit in order to elect benefits for your spouse. No person may be covered more than once under the policy.
Life Benefit Limitation: Voluntary benefits are not payable under certain scenarios such as suicide. Please refer to your full certificate book on bcbstx.com/ancillary-ut for detailed information on limitations.

WHEN IS MEDICAL EVIDENCE OF INSURABILITY (EOI) REQUIRED?	
Employee	EOI is required for any increase in coverage
Spouse	EOI is required for spouses who elect to enroll for coverage.*
*Note: EOI is not required for spouses who were covered while the retiree was an active employee and continued coverage under the retiree plan with no gap in coverage	

WHO PAYS THE PREMIUM?	
Basic Benefits	UT System pays 100% of the premium.
Voluntary Benefits	You pay 100% of the premium.
