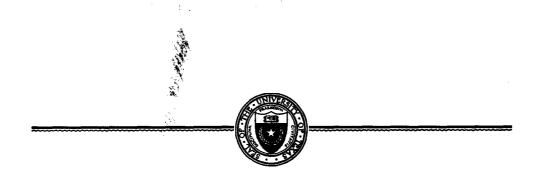

1. Policy Statement Relating to "Research Investigation Involving Human Beings --General Approach and Methods of Procedure.--Below is a xerox copy of Chancellor Ransom's recommendation:

The following procedures have been formulated by the Medical Affairs Council of The University of Texas and adopted by this group as the basic policy for use at all component medical institutions of The University of Texas System, following a review, historically and philosophically, of the principles of medical ethics as they relate to human experimentation, including those at the Nuremberg Trial Tribunals in 1947. These statements have been reviewed by University Attorney Waldrep, and it is the recommendation of the Medical Affairs Council and Chancellor Ransom that the Board of Regents approve the following statement:

I. GENERAL APPROACH

A. The voluntary consent of the human subject is absolutely essential. This means that the person involved, except as indicated below, should have legal capacity to give consent, should be so situated as to be able to exercise free power of choice without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject, the nature, duration, and purpose of the experiment should be made known to him; the method and means by which it is to be conducted; all inconveniences and hazards to be expected within reason; and the effects upon his health or person which may come from his participation in the experiment.

- 1. The "Consent to Investigational Procedure or Treatment" form is to be signed by all patients who are to undergo investigational procedures or treatments. If the subject is not competent, the person responsible shall be the legally appointed guardian or next of kin. If the subject is a minor under 21 years of age, the person responsible shall be the mother and father (both should sign) or legally appointed guardian.
- 2. The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs, or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity.

B. The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.

C. The experiment should be so designed and based on the results of nonhuman experimentation and on a knowledge of the natural history of the disease or other problem under study that the anticipated results will justify the performance of the experiment.

D. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.

E. No experiment should be conducted where there is an <u>a priori</u> reason to believe that death or disabling injury will occur; except, perhaps where the investigating physician himself is the subject of the experiment.

F. The degree of risk to be taken should never exceed the humanitarian importance of the problem to be solved by the experiment.

G. Proper preparations should be made and adequate facilities should be provided to protect the experimental subject against even remote possibilities of injury, disability, or death.

H. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required of those who conduct or engage in the experiment throughout all stages of the experiment.

I. During the course of the experiment, the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.

J. During the course of the experiment, the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill, and careful judgment required of him that continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.

II. METHODS OF PROCEDURE

A. All proposed research programs and projects involving human beings must be approved by the responsible department chairman, and a copy of the protocol submitted to the Research Review Committee (or the equivalent institutional committee) prior to the start of the project. That committee will review those research investigations in which, in the opinion of the committee chairman and the department chairman, there are unusual risks involved for study patients. In addition, all proposed projects in which isotopes are administered to humans must be reviewed by the Isotope Committee (or the equivalent institutional committee). In unusual cases, it may be necessary to appoint special committees of scientists from within the institution or prominent scientists from outside to assist the established committees.

B. In reviewing proposed experimental projects, the committees will determine whether:

1. the purpose of the research is well defined;

- the principles outlined in Research Investigations Involving Human Beings, section I, articles A through J, have been followed;
- 3. there are any risks involved to the study patient;
- 4. proper consideration has been given to biometrical design which should be observed in accordance with statistical principles wherever applicable

in order to reduce the sample size, thus limiting the exposure of human subjects to investigational risks.

C. When the investigation is completed and reports are prepared for publication, they must be written so as to leave no doubt in the mind of the reader that the investigation was justified and that all ethical requirements were fully met.

Nature of the Proposed Work

For the first time in history, real observational understanding of the nature of the universe is within our grasp (see, e.g., TIME magazine cover story for March 11). The principal contributions to this scientific revolution are now coming and will continue to come from research groups such as the CalTech-Palomar combination having access to (1) major optical telescopes, (2) theoretical physicists of the first rank who are interested in general relativity and cosmology, and (3) radio telescopes of the largest size.

Two of these three factors are already present at The University of Texas. The McDonald Observatory is one of the world's principal optical observatories; the new 107-inch telescope will be particularly well suited to optical observations of distant galaxies and radio sources. The Center for Relativity Theory, preeminent in its field, is intensely interested in cosmological problems. We now propose to construct, almost completely with Federal funding, the large radio telescope systems necessary to consolidate the University's position as one of the world's few outstandingly important contributors to these ultimate problems of astronomy.

In particular, as yet no one has even been able to carry out basic mapping of the radio sky fainter than the brightest several thousand sources. Most of these sources are relatively "nearby" (only a billion or so light years away); definitive answers to the cosmological questions will almost certainly require accurate and detailed knowledge of sources ten billion or more light years distant, out at what we presume to be the observable boundaries to our universe, both in space and in time. The proposed radio telescope system, much larger than any now in existence and one of the largest now being designed anywhere in the world, will be used to map and investigate the properties of about 100,000 of these extra-galactic radio sources, providing crucial information for cooperative optical and theoretical work. It will also be used for studies of our own galaxy, as well as of the sun, the planets, and the interplanetary medium.

The Radio Telescope

The principal radio telescope will consist of thousands of small antennas, arranged in a T-shaped configuration with E-W bar about 7 miles long and N-S bar about 3-1/2 miles long. This type of radio telescope

system is not only economical and versatile, but is also useful when only a few of the thousands of antennas have been installed. It will be built in separately funded steps, each step representing an increasingly useful instrument. The essential first step can be achieved as soon as land is available, since Yale University is transferring to Texas title to the prototype radio telescope system pioneered by Douglas while at Yale; this system is now enroute to Austin.

Principal Site Requirements

Construction of the 3-1/2 x 7 mile T-antenna requires an extraordinarily flat, dry area; even modest irregularities in the land or significant humidity would increase construction costs by several times. Even more important, the site must be remote from large cities and major air routes, to minimize man-made interference. Finally, easy access to small towns for staff residence, and to existing astronomical installations, is highly desirable to permit recruiting and retention of the necessary scientific and technical staff.

None of the University Lands were found to be satisfactory for this giant antenna system. No large areas of nearly perfect flatness are available. All University Lands are under busy and rapidly expanding air traffic lanes with their attendant high interference levels. And none of the University land is near scientific supporting activity.

The Proposed Site

The only site we have found in Texas which is excellent in all respects is a 3-1/2 x 7 mile rectangular area on the C. T. Mitchell Estate, 20 miles southeast of Marfa, Texas, relatively near the McDonald Observatory. The ranch, administered by F. W. Barton of Marfa, is owned by Mrs. Thelma Mitchell Barton, Mrs. Lois Mitchell Thompson, and Miss Katheryn Mitchell; grazing rights are now under lease to the Hayes Mitchell Cattle Company of Marfa. The owners have agreed to a draft lease form having the following principal provisions: (1) Initial lease will be for five years at \$15,000 per year for 15,680 acres; the University has the option to renew every five years at a negotiated and if necessary arbitrated rate, based on the economic value of the land for non-astronomical purposes. The University may cancel on one year's notice; the owners may never cancel, except by proving lease violation. (2) The University may sublet or otherwise permit other groups to make use of the land, within the terms of the lease. (3) Other clauses provide for the retention of mineral rights by the owners, and for grazing rights by the owners or their lessees on portions of the land not actually fenced off for astronomy.

In justifying their asking price, the owners have stated that their future bargaining position in setting prices for grazing, for mineral rights, or for land sales will be adversely affected by our indefinitely renewable long-term lease, also that substantial inconvenience to general ranch operations will result from the large scale of our operation.

Site Sharing

In addition to the possible simultaneous use of our radio telescope by groups from other universities (MIT has already expressed such an interest for its solar radar work), the site is big enough to accomodate several other complete radio telescopes. The University by encouraging other institutions to use the site, would considerably improve its value for all concerned. We expect that cost of land, equipment and maintenance will normally be shared with other users, but equally important will be the lessening of the scientific isolation of this remote site. Partly for this reason the National Science Foundation has on several occasions expressed a marked preference for supporting two or three multiple-use remote radio astronomy sites rather than ten to twenty individual ones. Our installation would provide the nucleus for the first of these multiple-use sites, in the most favorable location for radio astronomy development so far proposed in the United States.

Funding

Funds will be requested from NSF and NASA for a sequence of annual construction steps and for substantial astronomical operation of the equipment at each successive step. The utility of the growing system is thus not dependent on obtaining the entire construction funding at once, or indeed ever. While we have every expectation and confidence of funding this radio telescope to its completion, any decrease of construction funds at any point leaves an extremely valuable system in useful operation.

Chancellor Ransom concurs in the recommendation of President Woolf that \$50,000 be appropriated from Unappropriated Income at Arlington State College to apply toward the purchase of lands presently authorized to be purchased in Arlington for expansion of the campus.

Subject: Additional Funds to Complete Land Purchase

Dear Dr. Ransom:

The amount of funds available for land purchase is insufficient to complete the acquisition of properties which the Board has authorized for purchase. The primary reason for this is the increase in the expected price for two pieces of property which are now in a commercial area. So that we may proceed to complete this program, an additional appropriation of funds is requested. The statement below* shows an unencumbered balance of about \$14, 762. 02 and an estimate of needs of about \$43, 273. In order to provide funds for expenses, possible changes in land values, and possible court costs and awards at higher figures, it is recommended that \$50,000 be appropriated for land purchase. It should be emphasized that this is not a request for authority to purchase any additional properties, but merely to fund the purchase of the remainder of properties which are already authorized. It is requested that this item be considered for the Regents' Agenda on April 22, 1966.

Therefore, it is respectfully recommended that \$50,000 be appropriated from unappropriated income at the Arlington State College for the purchase of land, said appropriation to apply toward the purchase of lands already authorized to be purchased at Arlington.

11. OFFICE OF FACILITIES PLANNING AND CONSTRUCTION: AUTHORIZATION TO EMPLOY MECHANICAL ENGINEER.--At the October 8, 1965 meeting of the Board of Regents, the Director of the Office of Facilities Planning and Construction was authorized to negotiate for a Mechanical Engineer, with the understanding that his salary would be presented to the Board or the Executive Committee for approval. Advertisements were placed in newspapers and publications over the State, and many inquiries of Engineering and Architectural firms have been made over the past several months in an attempt to locate a qualified, experienced Mechanical Engineer.

After interviewing a number of applicants, it is the recommendation of E. D. Walker, concurred in by Chancellor Ransom, that the appointment of Atwell C. Lagow be approved as Mechanical Engineer in the Office of Facilities Planning and Construction at a salary of \$14,000.00 per year. Mr. Lagow is a Licensed Mechanical Engineer in the State of Texas with over twenty years experience in his field.

12. \$1,100,000 ARLINGTON STATE COLLEGE STUDENT FEE REVENUE BONDS, SERIES 1966 (SKILES ACT) - RECOMMENDATION FOR AGREEMENT TO SELL THE BONDS THROUGH RUSS & COMPANY.--At its April 2 meeting, the Board of Regents authorized the staff to make inquiries concerning the negotiated sale of subject bond issue to come within the limit of 4% interest set by the statute (Skiles Act). Inquiries were then made through The Fort Worth National Bank as to possibilities of placing this issue with Arlington, Dallas and Fort Worth Banks. This was pursued, with some hopes, by The Fort Worth National Bank, but they have now reported that the deal could not be arranged.

A proposal has been received from Russ & Company (see copies of their letter of April 11 and enclosures attached as supplemental material) for direct placement of the entire issue at a coupon rate of 4% on all of the bonds plus a premium of \$100 payable to the Board of Regents. Russ & Company proposes to assist in the issuance of the bonds, negotiation of call provisions, preparation of material to be furnished to the purchaser, except for resolutions and other legal instruments, and related services and to pay all of the costs of the issue, including printing, except for fee and expenses of bond counsel. The fee of Russ & Company, payable by the Board of Regents from bond proceeds, would be \$11,000.

This is a firm proposal on the part of Russ & Company and the prospective purchaser subject to acceptance by the Board of Regents by April 23, 1966, but the agreement will allow delivery of the bonds as late as July 31, 1966, (a change in the form of agreement submitted by Russ & Company) and will further provide that there is no obligation on the part of the Board of Regents to go through with the sale if plans for construction, construction bids, availability of Federal Funds to be used for part of the cost of the Mathematics-Language Building, and related matters have not been determined to the satisfaction of the Board of Regents in time for delivery of the bonds by July 31.

Based on available information to the present municipal bond market, prospects for the market, and the advisability of having construction contracts awarded as soon as possible, President Woolf and Central Administration recommend that the Board of Regents accept the proposal submitted by Russ & Company and authorize the Chairman to execute an appropriate agreement with Russ & Company when approved by the University Attorney, the Vice Chancellor (Fiscal Affairs) and the Endowment/Officer.

Dear Mr. Stewart:

Following our telephone conversation today I am enclosing herewith two copies of our proposal to act as your fiscal agent in the issuance and sale of the proposed \$1, 100, 000 Arlington State College Student Fee Revenue Bonds. I have rushed to get this proposal to you today, and if you desire any changes or corrections to be made, I will be glad to cooperate.

When you called me approximately one month ago concerning this issue, I felt at that time an effective interest rate of approximately 4.40% would have been required for the marketing of the issue. However, as you know, in the brief period of time since then, there has been a substantial improvement in the bond market. This improvement, together with unusual requirements of a particular buyer, has permitted us to negotiate the direct placement of the subject issue at a 4% effective interest rate. In my contract I state that a premium of \$100 will be paid and this will come from a rebate of our proposed fee in order to permit you to break a 4% basis.

There has been only one comparative issue sold within the past week, and this was a financing of Southern Illinois University in the amount of \$6,900,000, which was sold on April 7, 1966, at a net interest cost of 4.1855%. It is interesting to note that the second bid was 4.25%. Based upon this sale and comparative secondary market offerings now being shown, I consider the placement which we have negotiated to constitute the very top price obtainable for your bonds. As a matter of fact, in my opinion the placement is a minimum of .05 to .10 basis points better than could be obtained in any normal market for college revenue bonds. My opinion is based upon preliminary discussions of this issue with other college buyers and the fact that there are comparative offerings in the secondary market available at from .05 to .25 basis points higher yields on an average basis.

I understand that in the past the University of Texas has only infrequently handled the sale of their revenue bond issues by the direct placement method with ultimate investing institutions. As you know, we have handled in excess of \$20,000,000 of such direct placements in the past two years for other state colleges and universities in this state. In each of these instances where we have negotiated the direct placements it has been our feeling and that of our clients that this was the most advantageous method of marketing the bonds under the special circumstances which existed at the time. In this instance we feel the special market circumstances require a negotiated direct placement.

It is our understanding that you and Dr. Dolley will present this placement to your Board at their meeting this month. Upon approval by your Board, then the bond resolution could be passed at your May meeting, and delivery of the bonds could be made in June. This time schedule is satisfactory to us and the proposed purchaser.

I am sure you understand that if you do not accept our proposal, that you owe us nothing for our efforts to this point. I have enjoyed working on this and await further advices from you or Dr. Dolley. In the meantime, if you desire anything else on this matter, please advise me.

Dear Mr. Stewart:

1. We have previously discussed with you the proposed issuance and sale of \$1,100,000 Arlington State College Student Fee Revenue Bonds, to be issued on a parity with \$325,000 Arlington State College Student Revenue Bonds, Series 1965. Since we were employed as financial advisors on the aforementioned \$325,000 bond issue, we are, in general, familiar with the security to be offered on the proposed \$1,100,000 parity bonds issue. It is in connection with the issuance and sale of the proposed \$1,100,000 Arlington State College Student Fee Revenue Bonds, that we offer our services and our facilities as fiscal agents and agree to perform the following duties normally performed by such agents, and to perform such other duties as in our judgment may be necessary or advisable:

- (a) To assist you, if you desire, in the development of a definitive and final plan for the issuance of the \$1,100,000 bonds. In this connection we understand that you have already been working on such a plan and have determined that the \$1,100,000 bonds can be legally issued as additional parity bonds to the previous \$325,000 Arlington State College Student Fee Revenue Bonds, Series 1965; and that said bonds will be payable from a pledge of "Skiles Act" student fees. Further, it is our understanding that you propose to " mature the \$1,100,000 issue serially from two to approximately twenty-seven or twenty-eight years from the date of the issue. We have not previously discussed proposed call provisions to be included in the new issue. However, we agree to negotiate in your behalf the most favorable call provision obtainable. Such call provision in no event would exceed a premium of l percent for the privilege of calling bonds in advance of maturity no longer than 15 years from the date of the issue.
- (b) Based upon our understanding we have negotiated the direct placement of your proposed \$1,100,000 issue at par and accrued interest to delivery date, plus a premium of \$100. Our negotiated direct placement is with the understanding that the bonds will bear interest at the rate of 4 percent from their date to final maturity. As your agents, and upon your acceptance of this proposal, we will notify you of the purchasers of the subject \$1,100,000

bonds and will make full disclosure of any details that you desire in this connection.

- (c) To prepare all the necessary showings which will be required by the purchasers of the bonds.
- (d) To prepare the necessary material and make a presentation of same in New York to Standard & Poor's Investors Service for the purpose of obtaining a favorable rating on these \$1,100,000 bonds.
- (e) To arrange and pay for the expenses of delivering the \$1,100,000 bonds
 to the purchasers. In this connection it is our understanding that the bonds
 will be ready for delivery sometime during the month of June, 1966.
- (f) To prepare any showings which you desire for us to furnish your attorneys to aid in the preparation of the required bond resolution and other proceedings. Parenthetically, we understand that you will employ Messrs. McCall, Parkhurst & Horton to assist you in the steps necessary to be taken in the legal issuance
 - and final delivery of the \$1,100,000 bonds. It is our further understanding that you will pay the fees of such attorneys for legal services which shall include the preparation of all proceedings and the rendition of an unqualified approving opinion as to the legality of the \$1,100,000 bonds.
- (g) To attend to and pay for the printing of the bonds.
- (h) To pay the necessary expenses in obtaining the approving opinion of the Attorney General of the State of Texas and the registration of the bonds by the Comptroller of Public Accounts.
- (i) To prepare and furnish you at our expense a bond register covering this bond issue.

2. We agree to assist you in the co-ordination and accomplishment of the entire program of financing herein contemplated and to assume and pay the expenses enumerated.
3. As consideration for the services rendered by us and for expenses which we have incurred and will incur in this cause it is understood and agreed that you are to pay and that we are to accept a cash fee in the amount of \$10 per \$1,000 par value of the subject \$1,100,000 bonds. Such fee shall become due and payable simultaneously with the delivery of these bonds.

4. This proposal is submitted in duplicate originals. When accepted by you, it will constitute the entire agreement between your University and the undersigned for the purpose and considerations herein specified. Such agreement shall become

terminated by the delivery of the bonds contemplated herein. Your acceptance will be indicated by your signature on both copies and returning one executed copy to us.

Below is a report of the items that have been submitted to and unanimously approved by the Executive Committee. If these are found in order and are adopted by the Board, the following will appear in the minutes of the April 22-23 meeting:

REPORT OF INTERIM ACTIONS OF THE EXECUTIVE COMMITTEE.--Since the last report of the Executive Committee on April 1, 1966, the Committee has unanimously approved the following items and they are submitted for the Board's ratification:

a. Permission to Travel: Main University and Medical Branch:

- (1) Main University: Permission to Leonard Broom for Travel (2T-5). -- Permission was granted to Leonard Broom, Ashbel Smith Professor of Sociology, to go to Evian, France; Canberra, Australia; Tokyo, Japan from September 1 to October 8, 1966 to attend and deliver a paper at the Sixth World Congress of Sociology at Evian; to confer with research associates at the Australian National University and the Tokyo Kyoiku University. Mr. Broom's expenses to be reimbursed are \$1,500 for transportation and \$470 per diem (38 days) with the source of funds to come from the NSF Regular Graduate Fellowship Program.
- (2) Medical Branch: Permission to A. E. Rodin, M.D. for Travel (4T-5). -- Permission was granted to A. E. Rodin, M. D., Associate Professor of Pathology, to go to Chicago, Illinois from June 19 to July 30, 1966 to attend the "Educational Science for Medical Teachers". Doctor Rodin is to be reimbursed for expenses in the amount of \$1,000 covering a period of 42 days. This amount includes transportation, and the source of funds is Pathology Current Restricted Account No. 9-19311-644643-70.
- (3) Medical Branch: Permission to Melvyn H. Schreiber, M. D. for Travel (4T-6).--Permission was granted to Melvyn H. Schreiber, M. D., Associate Professor of Radiology, to go to Sweden, England, Denmark, Holland, France and Italy from May 29 to July 20, 1966 to visit centers of educational, medical and general learning where arrangements have been made to visit distinguished radiologists in their university departments, and to discuss mutual interests in research, teaching and practice. Doctor Schreiber's expense to be reimbursed is \$5,500 for a period of 40 to 50 days with the cost of transportation for self and family included. The source of funds for the trip will come from the John and Mary R. Markle Scholarship, Account No. 8-19927-685440-70.
- b. Amendments, 1965-66 Budgets (Main University, Medical Branch and Southwestern Medical School). -- The following amendments to the 1965-66 Budgets were approved for ratification as set out on the following pages.
