RESOLUTION

BY THE BOARD OF REGENTS OF THE UNIVERSITY OF TEXAS AUTHORIZING THE ISSUANCE OF BOARD OF REGENTS OF THE UNIVERSITY OF TEXAS PERMANENT UNIVERSITY FUND BONDS, SERIES 1959, IN THE AMOUNT OF \$4,000,000.00, BEARING INTEREST AT THE RATES HEREINAFTER SET FORTH, AND MATURING AS HEREINAFTER PRESCRIBED, FOR THE PURPOSE OF CONSTRUCTING, EQUIPPING OR ACQUIRING BUILDINGS OR OTHER PERMANENT IMPROVEMENTS, PRESCRIBING THE FORM OF THE BONDS, PLEDGING TO THE PAYMENT OF THE INTEREST AND PRINCIPAL THEREOF THE INTEREST OF THE UNIVERSITY IN THE INCOME DERIVED FROM THE PERMANENT UNIVERSITY FUND, PROVIDING FOR THE EXECUTION AND DELIVERY OF SAID BONDS AND PRESCRIBING THE DUTIES OF THE OFFICERS OF SAID BOARD AND OF THE STATE IN REFERENCE THERETO, AND MAKING CERTAIN COVENANTS WITH RESPECT TO SECURING PAYMENT OF SAID BONDS AND THE INTEREST THEREON.

WHEREAS, the Board of Regents of The University of Texas (hereinafter sometimes called the "Board") heretofore has authorized, issued and delivered that issue of Board of Regents of The University of Texas Permanent University Fund Refunding Bonds, Series 1958, dated July 1, 1958, and having been authorized pursuant to the provisions of Section 18, Article VII of the Constitution of Texas; and

WHEREAS, said Refunding Bonds, Series 1958, are payable from and secured by a first lien on and pledge of the Interest of The University of Texas in the income from the Permanent University Fund, in the manner and to the extent provided in the resolution authorizing said Refunding Bonds, Series 1958; and

WHEREAS, the resolution adopted on July 23, 1958, authorizing the issuance of said Refunding Bonds, Series 1958, reserves the right and power in the Board to issue, under certain conditions, Additional Parity Bonds and Notes for the purposes and to the extent provided in the Amendment to Section 18, Article VII of the Texas Constitution, adopted by vote of the people of Texas on November 6, 1956; said Additional Parity Bonds and Notes to be on a parity with the aforesaid Refunding Bonds, Series 1958, and equally and ratably secured by and payable from a first lien on and pledge of the Interest of The University of Texas in the income from the Permanent University Fund, in the same manner and to the same extent as are said Refunding Bonds, Series 1958; and

WHEREAS, the Amendment to Section 18, Article VII of the Texas Constitution adopted by vote of the people of Texas on November 6, 1956, provides that the Board is authorized to issue negotiable bonds and notes for the purpose of constructing, equipping or acquiring buildings or other

permanent improvements for The University of Texas System, in a total amount not to exceed two-thirds (2/3) of Twenty per cent (20%) of the value of the Permanent University Fund exclusive of real estate at the time of any issuance thereof; and

whereas, the Board has determined to authorize, issue, sell and deliver an installment or issue of negotiable bonds in the amount of \$4,000,000.00 for such constitutional purpose, to constitute Additional Parity Bonds as described above; and

WHEREAS, all conditions and requirements in connection with the issuance of such installment or issue of Additional Parity Bonds have been or will be met prior to the delivery thereof;

BE IT RESOLVED BY THE BOARD OF REGENTS OF THE UNIVERSITY OF TEXAS:

1. <u>Definitions</u>. Throughout this resolution the following terms and expressions as used herein shall have the meanings set forth below:

The term "Permanent University Fund," "Permanent Fund," and "Fund" used interchangeably herein shall mean the Permanent University Fund as created by Article VII, Section 11 of the Constitution, further implemented by the provisions of Title 49, Chapter 1 of the Revised Statutes of Texas, 1925, as amended and supplemented.

The expression "Interest of the University" in the Permanent University Fund shall mean all of the income to such Fund from grazing leases on University lands, and all of the other income from such Fund, after making provision for the payment of the University's proportion of the expense of administering such Fund, excepting one-third of the income arising and accruing to the Agricultural and Mechanical College of Texas from the 1,000,000 acres of land appropriated by the Constitution of 1876 and the land appropriated by the Act of 1883, as more particularly defined by Chapter 42, Acts of the Forty-second Legislature, Regular Session, 1931 (Article 2592, Vernon's Annotated Civil Statutes of Texas).

The term "Resolution" as used herein and in the Bonds shall mean this resolution authorizing the Bonds.

The term "University" as used herein shall refer to The University of Texas.

The term "Bonds" shall mean the issue of bonds authorized in this Resolution, unless the context clearly indicates otherwise.

The term "Refunding Bonds, Series 1958" shall mean that issue of Board of Regents of The University of Texas Permanent University Fund Refunding Bonds, Series 1958, dated July 1, 1958, originally issued in the amount of \$5,076,000.00.

The term "Additional Parity Bonds and Notes" shall mean the additional parity bonds and the additional parity notes permitted to be issued pursuant to Section 17 of the Resolution dated July 23, 1958, authorizing the issuance of the Refunding Bonds, Series 1958, and further referred to in this Resolution.

The term "Board" shall mean the Board of Regents of The University of Texas.

- 2. That for the purpose of constructing, equipping or acquiring buildings or other permanent improvements for The University of Texas System, to the extent and in the manner provided by law, there shall be issued the negotiable Bonds of the Board of Regents of The University of Texas in the principal amount of Four Million Dollars (\$4,000,000.00).
- 3. Said Bonds shall be known as "Board of Regents of The University of Texas Permanent University Fund Bonds, Series 1959"; shall be in the denomination of One Thousand Dollars (\$1,000.00) each, numbered from One (1) to Four Thousand (4,000), both inclusive; and shall bear interest from their date at the following rates:

Bonds Nos. 1 to 1360, both inclusive, 2 % per annum; Bonds Nos. 1361 to 1766, both inclusive, 34 % per annum; Bonds Nos. 1761 to 4000, both inclusive, 3.40 % per annum; payable January 1, 1960, and semi-annually thereafter on July 1 and January 1 of each year until said Bonds are fully paid.

4. Said Bonds shall be dated July 1, 1959, and shall become due and payable serially as follows:

Each of the Bonds of this issue maturing on and after July 1, 1970 shall be subject to redemption prior to maturity on July 1, 1969 and on any interest payment date thereafter at the price effective on such date determined as follows: par and accrued interest to the date so fixed for redemption, plus a premium of 2% of the par value if redeemed on or prior to January 1, 1974, such premium to be reduced on and after July 1, 1974 to 1%. Notice of intention to redeem Bonds shall be published in a financial publication in the City of New York, New York, at least once, not less than thirty (30) days before the date fixed for redemption, and at least thirty (30) days' notice in writing prior to the date fixed for redemption shall be given to the places of payment. If, by the date fixed for redemption, funds shall have been made available sufficient to pay any Bond so called for redemption and accrued interest thereon plus the premium specified, it shall not thereafter bear interest. In the event less than all of the Bonds outstanding then eligible for redemption shall be thus called the Bonds then proposed to be redeemed shall be called in inverse numerical order.

- 6. Each of said Bonds and the coupons attached thereto shall be executed by the imprinted facsimile signatures of the Chairman of the Board and the Secretary of the Board, and such facsimile signatures shall have the same effect as manual signatures, and the corporate seal of the Board shall be impressed upon each of the Bonds.
- 7. Said Bonds, at the option of the holder, shall be registerable as to principal only on the books of the Registrar, and for

such purpose the Comptroller of the University is hereby designated "Registrar."

Such registration shall be noted also on the Bonds thus registered and after such registration no transfer of such Bonds shall be valid unless made on the books of the Registrar at the instance of the registered holder or his lawful attorney, thereunto duly authorized, and similarly noted on the Bonds. Bonds thus registered may be discharged from registration by being transferred to bearer, after which they shall be transferable by delivery, but may be again registered as to principal as before. Bonds not so registered or which have been so transferred to bearer shall be in all respects negotiable. The registration of Bonds as to principal shall not restrain the negotiability by delivery of the coupons appertaining thereto.

Subject to the provisions for registration as to principal alone hereinabove provided, nothing contained in the Bonds or in this Resolution shall affect or impair the negotiability of the Bonds and said Bonds shall constitute negotiable instruments within the meaning of the Uniform Negotiable Instruments Act of the State of Texas.

The date of this bond, in conformity with the Resolution, is July 1, 1959.

*(Each of the bonds of this issue maturing on and after July 1, 1970, shall be subject to redemption prior to maturity on July 1, 1969 and on any interest payment date thereafter at the price effective on such date determined as follows: par and accrued interest to the date so fixed for redemption, plus a premium of 2% of the par value if redeemed on or prior to January 1, 1974, such premium to be reduced on and after July 1, 1974 to 1%. Notice of intention to redeem bonds shall be published in a financial publication in the City of New York, New York, at least once, not less than thirty (30) days before the date fixed for redemption, and at least thirty (30) days' notice in writing prior to the date fixed for redemption shall be given to the places of payment. If, by the date fixed for redemption, funds shall have been made available sufficient to pay any such bond so called for redemption and accrued interest thereon plus the premium specified, it shall not thereafter bear interest. In the event less than all of the bonds outstanding then eligible for redemption shall be thus called the bonds then proposed to be redeemed shall be called in inverse numerical order.)

This bond and the series of which it is a part are in all respects of equal dignity and on a parity with that issue of Board of Regents

of The University of Texas Permanent University Fund Refunding Bonds, Series 1958, dated July 1, 1958, with this bond and the series of which it is a part constituting "Additional Parity Bonds" as permitted by Section 17 of the resolution dated July 23, 1958, authorizing said Refunding Bonds, Series 1958. All of said Refunding Bonds, Series 1958 and this bond and the series of which it is a part are equally and ratably secured by and payable from a first lien on and pledge of the Interest (as such term is defined in the Resolution) of The University of Texas in the income from the Permanent University Fund, as such Interest is apportioned by Chapter 42 of the Acts of the Regular Session of the Forty-second Legislature of Texas.

Subject to the terms and conditions referred to in the Resolution, the Board reserves the right to issue other Additional Parity Bonds and Notes which shall be equally and ratably payable from the same source and secured in the same manner as the aforesaid Refunding Bonds, Series 1958, and this bond and the series of which it is a part.

This bond is registerable as to principal only on the books of the Registrar. For such purpose the Comptroller of The University of Texas has been designated "Registrar." If registered, the fact of registration is to be noted on the back hereof and thereafter no transfer of this bond shall be valid unless made on the books of Registrar at the instance of the registered holder and similarly noted hereon. Registration as to principal may be discharged by transfer to bearer, after which this bond may again be registered as before. The registration of this bond as to principal shall not restrain the negotiability of the coupons pertaining hereto, which shall continue to be negotiable by delivery merely.

Subject to the provision for registration as to principal alone endorsed hereon and contained in the Resolution, nothing contained in this bond nor in said Resolution shall affect or impair the negotiability of this bond and this bond shall constitute a negotiable instrument within the meaning of the Uniform Negotiable Instruments Act of the State of Texas.

- (b) Pursuant to the authority conferred upon the Board by the provisions of Section 18, Article VII of the Texas Constitution, approved by vote of the people of Texas on August 23, 1947, and pursuant to the provisions of the amendment to said Section 18, Article VII, approved by vote of the people of Texas on November 6, 1956, and pursuant to the provisions of Chapter 255, page 546, Acts of 1957, Fifty-fifth Legislature of Texas, Regular Session, the aforesaid Refunding Bonds, Series 1958, together with the Bonds authorized by this Resolution and all other Additional Parity Bonds and Notes, when issued pursuant to the provisions of Section 17 of the above described resolution authorizing the issuance of said Refunding Bonds, Series 1958, and the interest on all of same, shall be and are hereby equally and ratably secured by and payable from a first lien on and pledge of the Interest of the University in the income from the Permanent University Fund as such Interest is defined in Section 1 of this Resolution.
- thorizing the issuance of said Refunding Bonds, Series 1958, has provided that the Comptroller of Public Accounts of the State of Texas shall establish in the State Treasury a fund to be known as "Board of Regents of The University of Texas Permanent University Fund Interest and Sinking Fund" (hereinafter called the "Interest and Sinking Fund"). In addition to the moneys required to be transferred to the credit of the Interest and Sinking Fund in connection with said Refunding Bonds, Series 1958, the Comptroller of Public Accounts of the State of Texas shall, for the benefit of the Bonds herein authorized, transfer to the Interest and Sinking Fund out of The University of Texas Available University Fund (the fund in the State Treasury to which is deposited the Interest of the University), on or before November 1, 1959, and

semi-annually thereafter on or before May 1 and November 1 of each year while the Bonds or interest thereon are outstanding and unpaid, a sum of money equal to the amount of interest or principal and interest (when both are scheduled to accrue and mature) which will become due on the Bonds on the January 1 or July 1 next following.

- (b) To the end that money will be available at the places of payment in ample time to pay the principal of and the interest on the Bonds as such principal and interest respectively mature, on or before November 5, 1959, and semi-annually thereafter on or before May 5 and November 5 of each year while any of the Bonds or interest thereon are outstanding and unpaid, the Comptroller of the University, or such officer as may hereafter be designated by the Board to perform the duties now vested in such officer, shall perform the following duties:
 - (1) Prepare and file with the Comptroller of Public Accounts of the State of Texas (hereinafter called the "Comptroller of Public Accounts") a voucher based on which the Comptroller of Public Accounts shall draw a warrant against the Interest and Sinking Fund in the amount of the interest or principal and interest (when both are scheduled to accrue and mature) which will become due on the January 1 or July 1 next following.
 - (2) In the event Bonds shall have been called for redemption on January 1 or July 1 next following of any year, prepare and file with the Comptroller of Public Accounts a voucher based on which the Comptroller of Public Accounts shall draw a warrant against funds of the University legally available for such purpose in an amount sufficient to redeem the Bonds thus called.
- (c) Whenever a voucher is so filed with the Comptroller of Public Accounts, he shall make the warrant based thereon payable to the order of that place of payment situated in the State of Texas, specified in Section 5 above, and shall deliver such warrant to such place of payment on, or before the November 15 or May 15 next following.
- (d) The place of payment situated in the State of Texas, designated in Section 5 hereof, shall, out of moneys remitted to it under the provisions of Section 13 hereof, and not otherwise, make available at the other places of payment specified in Section 5 hereof, funds sufficient to pay such of the Bonds (whether payable to the bearer or payable to the registered holder thereof) and such of the coupons as are presented for payment at such places of payment and said place of payment situated in the State of Texas by accepting designation as such place of payment agrees and is obligated to perform such service.

- (e) All Bonds and coupons paid by the places of payment, after cancellation by perforation, shall be forwarded by such places of payment to the University at Austin, Texas.
- (f) The Board of Regents shall make provision with the places of payment designated as paying agents for the rendition of a statement to the University for any sums due such paying agents for services rendered in connection with the payment of the coupons and Bonds by such paying agents and the amount of such charges shall be paid by the University from funds available for such purpose.
- 14. That all of the language, terms, provisions, coverants and agreements of Sections 15 through 19, both inclusive, of the resolution dated July 23, 1958, authorizing the issuance of the Refunding Bonds, Series 1958, be and are hereby referred to, adopted and made applicable to the Bonds authorized by this Resolution for all purposes.
- shall be the duty of the Chairman of the Board or some officer of the Board acting under authority from him to deliver said Bonds to the Attorney General of Texas, for examination and approval by the Attorney General. After said Bonds shall have been approved by the Attorney General, they shall be delivered to the Comptroller of Public Accounts of the State of Texas for registration. Upon registration of said Bonds, the Comptroller of Public Accounts (or a deputy lawfully designated in writing to act for the Comptroller) shall manually sign the Comptroller's certificate of registration prescribed herein to be printed on the back of each Bond, and the seal of said Comptroller shall be affixed to each of said Bonds.

16. That the sale of the Bonds herein authorized to a fundate fluid by Thelps, Tenn + Co. Mulyou, h, y at a price of par and accrued interest to date of delivery, plus a premium of \$_____, is hereby confirmed. Delivery of such Bonds shall be made to such purchaser as soon as may be after the adoption of this Resolution upon payment therefor in accordance with the terms of sale.

Meeting of the Board of Regents (Following Joint Meeting) II.

A. TEXAS HIGHWAY DEPARTMENT - RIGHT OF WAY FOR CONTROLLED ACCESS HIGHWAY NO. 10 UNDER INTERSTATE HIGHWAY PROGRAM. At the June 13, 1959 meeting of the Board of Regents, the matter of rights of way on University Lands in connection with the Interstate Highway Program was considered, particularly as it pertains to Interstate Highway No. 10 for 341.67 acres of University Lands in Block L, University Lands, El Paso County, Easement No. 1193 for this highway was authorized by the Board of Regents at its December 12, 1958 meeting but question as to the form of instrument had delayed the execution of the instrument. Under this highway system, the Highway Department is reimbursed 90% from Federal Funds for such construction and it has been the policy of the Texas Highway Commission to require fee simple title. It has, however, been the policy of the Board of Regents to grant easements but not fee simple title for other highway construction over the years and there has been no consideration involved. It is proposed that the University would receive \$5,566 for the 341.67 acres in El Paso County,

The Board of Regents agreed at the June 13, 1959 meeting to consider this matter as a special item of business at the meeting on July 9, 1959. The form of instrument on a determinable fee basis with reversion of the land to the University if and when the highway is abandoned, and with reservation of all minerals, has now been agreed upon between the University Staff and the Highway Department. A copy of the form for such instrument is attached as well as a copy of a letter from Mr. D. C. Greer, State Highway Engineer, dated June 19, 1959 HIt is recommended that this form be approved with the instrument to be submitted to the Chairman for signature.

In connection with Interstate Highway No. 10 in El Paso County, the matter of channel easements has not yet been submitted to the Board pending the decisions on the larger project. However, as indicated in Mr. Greer's letter, easement rights for drainage purposes continue to be acceptable according to past procedure. It is therefore recommended that channel easements for Interstate Highway No. 10 be granted to covering approximately 18 acres in Block 1, Sections 12, 13, 16, 17, 19, 21, 22, and 24 for which a consideration of \$102.00 will be received by the University and that the Chairman be authorized to execute the instrument upon approval by the University Attorney and Endowment Officer.

Reference is made to Endowment Officer W. W. Stewart's letter of June 15 in which he formally advised of the action taken at the June 13 meeting concerning the land needed by the State Highway Department for Interstate Highway 10 in MI Paso County.

In keeping with the desire expressed at the Board of Regent's meeting on June 13, the purpose of this letter is to inform each Board member as to the position of the Highway Department in order that the same harmonious relationship will continue as in the past. Although no official action was taken in regard thereto, the discussion at the June meeting indicated that the conveyance by the University of determinable fee title would be a mutually acceptable method of accomplishing the objectives and desires of both State agencies. We wish to advise that where rights of way proper are being acquired from University lands for the Mational System of Interstate and Defense Highways, the conveyance of determinable fee title to the land, excluding oil, gas and sulphur, but including exploration rights thereon, will be acceptable to the Highway Department. Also, it will be acceptable for the conveyance instrument to clearly provide that if the land is abandened for highway purposes, the fee title is to revert to the University of Texas. Masenent rights for drainage way purposes and material pits outside the right of way proper will continue to be acceptable according to past procedure. For all other highway systems, an easement for highway purposes will be satisfactory in every instance.

In order that everyone will have a clear understanding of what is involved, a brief review leading up to the present El Paso County project is desmed appropriate. In the past, all rights of ways for the various State Highway Systems were acquired by the counties or cities. The Federal Aid Highway Act of 1956, in respect to the Matienal System of Interstate and Defense Highways, established certain predicates. In order to assure the expeditious acquisition of the necessary property rights, State Highway Department handling was deemed necessary.

An important requirement of this Act is the unquestioned control of access deemed necessary to protect the integrity of the facility to safely handle large volumes of fast moving traffic on this multi-billion dollar undertaking. This point is illustrated by Title 23, United States Code, Paragraph 111. Agreements Relating to Use of an Access to Rights of Way - Interstate System, which provide in part:

"Such agreements shall also contain a clause providing that the State shall not permit automotive service stations or other commercial establishments for serving metor vehicle users to be constructed or located on the rights of way of the Interstate System. This provision spotlights a problem we are continuously encountering on the existing State Highway System at locations where we are on essement title. Encroachments of various types are made between the right of way line and the outer edge of the roadway under the contention that such space, not being actually covered with a roadway, is not being used for highway purposes; notwithstanding it is needed for highway purposes other than roadway use. Accordingly, in order to effectively obtain full control of Interstate Highway rights of way as required by the Bureau of Public Roads in such agreements, it is highly important that the Department acquires no less than determinable fee title to University lands so as to give full control of the surface usage.

The Bureau approved the building of a portion of this same highway in Hudspeth County on a portion of University lands where only an easement was obtained from the University because this interest was acquired by the county prior to the time the State Highway Department took over the acquisition of rights of way for the National System of Interstate and Defense Highways. Likewise, other parts of the Interstate System are on easement, but all predate the present Federal requirements. It was with this background that the application was made October 21, 1958, for fee title to 341.671 acres for the right of way needed for this El Paso Gounty project, save and excepting oil, gas and sulphur.

The policy established in the past by the Board of Regents that no University land would be seld is a wise policy of which no one questions the wisdom. We fully appreciate your position in this matter of not wishing to convey away such lands, yet at the same time extend your wholehearted co-operation as expressed at the June 13 meeting. Such action is in keeping with the decision of the Legislature, as expressed in Article 6674w-3, V. A. C. S. (House Bill 179, Acts of the 55th Legislature, 1957). Therefore, it appears that the conveyance of a determinable fee estate will accomplish the desires of both State agencies. Absolute control of the right of way by the State Highway Department during the life of the highway, and reversion of the title to the property to the University of Texas if and when the land is abandoned for highway purposes will be accomplished through this medium. Of course, the instrument would reserve unto the University the oil, gas and sulphur but would weive any exploration rights on the land conveyed.

While abandonment of this location is not foreseeable in the lifetime of most of us, navartheless the conveyance of determinable fee with a reversionary clause in the instrument will be compatible with the statute governing disposition of rights of way, Article 6673a, V. A. C. S. which expressly provides in sub-section (d) of Section 1 that reconveyance is authorized was necessary to comply with reversionary clauses and instruments by which the State's title, rights, or interests were acquired. It might be noted that this same statute provides for a priority whenever abandoned right of way is sold which is as follows:

- W(1) To abutting or adjoining landowners;
- *(2) To eriginal granters, heirs or assigns of the original tract from whence the right of way was conveyed; or

Therefore, if and when such right of way is abandoned the University will be in position to regain title to this land under the reversionary clause.

Because of the opinions expressed at the June 13 meeting that the determinable fee with an express reversionary clause would be a means of accomplishing the objectives of both State agencies, the proposed El Paso construction contract was not removed from the June 16 letting. The actual award of the contract and issuance of the work order to the contractor will not be completed prior to your July 9 meeting. Since it was stipulated at the June 13 meeting that this matter would be considered at the executive session meeting on July 9, it is requested that authorisation be granted for the execution of a determinable fee, save and excepting oil, gas and sulphur and with no exploration rights thereon, with a reversionary clause to the University of Texas in the event the land described therein is abandoned for highway purposes. The State Highway Department will pay \$5,566.00 to the University of Texas for the conveyance of the determinable fee title to this 341.671 acres.

While attention has centered on the property interest to be conveyed for the right of way, we trust no question exists concerning the granting of the drainage channel easements for a consideration of \$102.00 and that authority for the execution thereof will likewise be covered at this meeting.

We trust this letter resolves this matter in a method which is acceptable to all concerned and that the harmonious relationship between the University and the Highway Department will continue on the same high level as enjoyed in the past. We assume that the establishment of this procedure as to rights of way for the Interstate System will permit the future handling of any applications the Department must make, in a routine manner without unduly burdening your time at your official meetings.

That the Board of Regents of The University of Texas, for and in consideration of the sum of Five Thousand Five Hundred Sixty Six and No/100 (\$5,566.00) Dollars, to it in hand paid by the State Highway Department of the State of Texas, acting herein by and through the State Highway Commission, the receipt of which is hereby acknowledged has this day GRANTED, SOLD and CONVEYED and does by these presents GRANT, SELL and CONVEY unto the State Highway Department of the State of Texas, subject to the conditions and limitations hereinafter provided, all those certain tracts or parcels of land out of Sections 12, 13, 16, 17, 19, 21 and 22, Block L, University Lands situated in the County of El Paso, State of Texas, said tracts or parcels of land being more particularly described as follows, to-wit:

(341.67 acres to be described in detail by metes and bounds)

TO HAVE AND TO HOLD the above described premises, together with all and singular the rights and appurtenances thereto in anywise belonging, unto the said State Highway Department of the State of Texas, its successors and assigns, subject to the conditions and limitations hereinafter provided.

The premises hereby conveyed are to be used for highway purposes, and in the event that said premises or any part thereof shall be abandoned for said purposes, then and in that event only, such premises or so much thereof as shall be actually abandoned, shall absolutely revert to and revest in the Board of Regents of The University of Texas, its successors or assigns, without the necessity of any further act, suit or action on the part of either party herein; provided, however, that the State Highway Department of the State of Texas does hereby agree in such event to execute and deliver or have executed and delivered to the Board of Regents of The University of Texas, its successors or assigns, a proper deed of reconveyance in order to clear the record title to said premises, or part thereof, upon the written request of the Board of Regents of The University of Texas, its successors or assigns, therefor.

It is further understood and agreed that the Beard of Regents of The University of Texas reserves all of the oil, gas, sulphur and other minerals in and under said land, but waives all rights of ingress and egress for the purpose of exploring, developing, mining or drilling for the same; provided however, the Board of Regents of The University of Texas shall have authority to execute leases for the development of oil, gas, sulphur and other minerals under remaining lands adjoining the above described premises, and may provide for directional drilling under the surface of the above described premises from such adjoining and remaining lands.

Following President Wilson's conversations with Dr. Minter in which approval was given to approach the consultants recommended in Dr. Casberg's memorandum of July 1, 1959, each of the five consultants was contacted by telephone. Drs. Anderson and Armstrong, due to other pressing duties, were unable to act favorably on the request. Drs. Hinsey, Rourke, and Warren have accepted to function as consultants and Dr. Hinsey, with the knowledge of the others, has agreed to act as chairman.

In view of the national stature of the three men who have indicated a willingness to serve, as well as the brevity of time, it would seem wise to limit the number of consultants to those now contacted.

Following final action by the Board of Regents, Dr. Hinsey, the chairman, upon notification, will arrange a schedule of visitation suitable to all three consultants. Each of these men should be informed of Regental approval immediately following the Board meetings in order that they may plan their summer schedules.

As a preliminary to this memorandum, immediately following the action of the Board of Regents at their June 15, 1959 meeting, ten of the more recently established schools of medicine were requested to recommend consultants for a survey in relation to the founding of a medical school in Bexar County. In view of summer vacations and other distractions of this time of the year, only three schools have responded as of this date.

It is my recommendation that the following men, all of whom are known to me personally, be approached to make the preliminary survey:

- 1. Dr. Joseph C. Hinsey, Chairman Director New York Hospital -- Cornell Medical Center 525 East 68th Street New York 21, New York
- 2. Dr. Anthony J. J. Rourke Hospital Consultant 26 Overlook Circle New Rochelle, New York
- 3. Dr. Stafford Warren, Dean School of Medicine University of California at Los Angeles Los Angeles 24, California
- 4. Dr. George Armstrong, Director New York University Bellevue Medical Center 550 First Avenue New York 16, New York

5. Dr. Donald Anderson, Dean School of Medicine and Dentistry The University of Rochester 260 Crittendon Boulevard Rochester 20, New York

These men as a group present a broad background of medical education and hospital administration, each of whom is well known on the national scene. Dr. Hinsey is known as the "senior citizen" in American medical education and is familiar not only with the national picture but also knows the situation in Texas.

Dr. Rourke is an able hospital consultant who has served in a variety of capacities including the presidency of the American Hospital Association. At one time, for a period of years, he was the administrator of the Stanford University Hospital in San Francisco.

Dr. Stafford Warren, besides being a man of international reputation in atomic medicine, has planned and built one of the most recent medical schools in the country.

Dr. George Armstrong, past Surgeon General of the Army, has established an enviable reputation among the medical educators. His military background would prove of value in the Bexar County setting.

Dr. Donald Anderson served for many years as secretary of the Council on Medical Education and Hospitals of the American Medical Association. In this capacity he had the opportunity to survey most of the medical schools of the country.

On the basis of an optimum class size of 100 students, the problems to which the members of this committee should address themselves are general in scope and should relate to:

- 1. The location of the school in Bexar County. Currently two alternatives present themselves with local elements supporting each location.
- 2. The needs for teaching hospital beds, both in terms of new construction and the suitability of existing heds.
- 3. The approximate cost to the State both in capital investment and annual operational expenses.
