Mrs. Devall and Gentlemen:

The dockets prepared by the component institutions listed below are herewith submitted, with my recommendation for approval, for consideration at the meeting of the Board of Regents in El Paso on December 12 and 13, 1958:

I recommend approval of the following:

1958-59 Budget

Office of the President

1. Change the appointment of Mrs. Mary S. Henderson from Senior Secretary (half-time)(temporary status) at \$1,512 for twelve months, to Administrative Clerk, full-time, at a twelve month rate of \$3,480, effective October 6, 1958, funds to come from unused salaries and Central Administration Unappropriated Balance.

OUT-OF-STATE TRIPS: I recommend approval of the following out-of-state trips, expenses to be paid as indicated:

- 1. Dr. Logan Wilson, President, September 3-9, 1958, to New York City to confer with various foundations concerning University proposals and to interview possible candidates for administrative positions, and to Washington, D. C., to represent the University at a joint meeting of the Association of American Universities and the Association of Universities of the British Commonwealth, a portion of the expenses to be paid from Clerical Assistants, Office and Travel account of the Office of the President; and to Washington, D. C., to attend the meeting of the Board of Trustees of the Committee on Economic Development on November 18, 1958, expenses to be paid from Development Expense Central Administration.
- 2. Dr. M. A. Casberg, Vice-President for Medical Affairs, October 1-4, 1958, to Chicago, Illinois, to attend the meeting of the American Association for the Surgery of Trauma; and November 8-13, 1958, to attend the Pre-Professional Education Conference in Buck Hill Falls, Pennsylvania, expenses for both meetings to be paid from the Clerical Assistants, Office and Travel Expense account of the Office of the President.
- 3. Mr. Hulon W. Black, Director, University Development Board, November 14-21, 1958, to New York City, for various conferences in connection with work of the Development Board, expenses to be paid from travel funds of the Development Board, and possibly from Supplemental Traveling Expenses and Entertainment Fund.

GRADUATE FACULTY LEGISLATION: The Graduate Legislative Council, at its regular meeting held on October 27, 1958, approved the following item proposed by the Graduate Council. I recommend approval.

Special Membership in the Graduate Faculty, and Special Associate of the Graduate Faculty. (D. and P., pages 172 and 174)

Craduate Faculty Legislation (continued)

There is a special category of membership in the Graduate Faculty reserved for those who have all the qualifications for membership except for the nature of their University appointment. Such persons shall have all the prerogatives of membership except that their appointments shall terminate on August 31 of even-numbered years. The appointments may be renewed by action of the Graduate Council without further recommendations from Committees on Graduate Studies. The word "Special" shall be inserted following their names on the roll of membership.

The same provisions shall apply with respect to a special category as Associates of the Graduate Faculty.

GRADUATE FACULTY MEMBERSHIP: The Graduate Council at its meeting on November 7, 1958, approved the following for membership in the Graduate Faculty. The Dean of the Graduate School has indicated the concurrence of the officers of the Graduate School in this action, and I recommend approval. These men are on the staff of the Main University and this recommendation is included in that docket also.

RESEARCH CONTRACTS: The following contracts and amendments have been negotiated by the Office of Government Sponsored Research and have been signed by the Vice-President and/or President upon the recommendation of the appropriate Technical Director, the Director of the Office of Government Sponsored Research, and the Business Manager. I recommend your approval and ratification of signatures:

- 1. Supplemental Agreement No. 2 to Basic Agreement No. AF 18(600)-240, by which the Department of the Air Force, Air Research and Development Command, brings the agreement into conformity with the latest requirements of the Armed Services Procurement Regulations and Air Force Procurement Instructions.
- 2. Supplemental Agreement No. 4 to Contract AF 19(604)-2249, by which the Department of the Air Force, Air Research and Development Command, adds the sum of \$6,500.00 to the contract funds and amends the scope of the work. The studies in tropospheric propagation continue at the Electrical Engineering Research Laboratory under the direction of Dr. A. W. Straiton, Professor of Electrical Engineering.
- 3. Supplemental Agreement No. 11 to Contract AF 33(038)-20681, b; which the Department of the Air Force, Office of Scientific Research, adds the sum of \$30,000.00 to the contract funds and extends the period of the contract through September 30, 1959. The research on interactions of neutrons with matter continues in the Nuclear Physics Laboratory under the direction of Dr. E. L. Hudspeth, Professor of Physics.
- 4. Modification No. 1 to Contract DA-18-064-404-CML-386, by which the Department of the Army, Chemical Corps, transfers accountability of the equipment held under Contract DA-18-064-404-CML-264 to the successor Contract DA-18-064-404-CML-386. I recommend also that approval be given to the following statement in regard to Kinsolving Dormitory submitted by Mr. G. W. Landrum, Business Manager:

"Since Kinsolving Dormitory has been approved for summer conferences and rates have been established and approved for conferees, we have not recommended a student rate for Kinsolving Dormitory. In the event that it is necessary to open a portion of Kinsolving Dormitory to students, we ask permission to set these rates realistically. The minimum rate to be charged would not be less than the Blanton Dormitory rate for students, and the rate would not be in excess of the Kinsolving Dormitory rate for conferees. It will be very difficult to operate a dormitory program and a conferee program within the same facility and provide dormitory service to one group and hotel service to another group."

Hospitalization and Union Fees: For the nine weeks' summer session, I recommend that a hospitalization fee of \$3.00. and a Union fee of \$3.75. be approved.

GRADUATE FACULTY MEMBERSHIP: The Graduate Council at its meeting on November 7, 1958, approved the following for membership in the Graduate Faculty:

John Julius Biesele, Professor of Zoology Robert Louis-Folk, Associate Professor of Geology

The Dean of the Graduate School has indicated the concurrence of the officers of the Graduate School in this action, and I recommend approval.

Also, the following corrections should be made in the 1958-59 Budget regarding Graduate Faculty membership: Mr. W. R. Neville, Professor of Pharmacy, should not be listed on the Graduate Faculty, and Mrs. Thelma A. Bollman, Associate Professor of Curriculum and Instruction, should be so listed.

FACULTY LEGISLATION: I recommend approval of the following legislation passed by the Faculty Council:

The Faculty Council at its meeting of October 20, 1958, approved the Summer Session 1959 Calendar and the 1959-60 Long Session Calendar (D&P 2613-15) with amendment that "September 11, Friday. Opening of the Long Semester," be added, and also approved the proposed quantity of work rule for the nine-week summer session (D&P 2616) with amendment that a student who needs to take as many as 12 hours in the 1959 session in order to get his degree in August may be permitted to do so. Copies of both legislations are attached hereto as APPENDIX A and APPENDIX B, respectively.

OUTSIDE AND ADDITIONAL DUTIES: I recommend that the staff members listed be permitted to undertake the outside and additional duties outlined, the work to be arranged so as not to interfere with University assignments:

- 1. Mr. Fabor Etier, Associate Professor of Business Services, to participate in secretarial workshops and clinics, total remuneration to be less than \$500.
- 2. Mr. W. G. Wolfe, Professor of Educational Psychology, to serve as consultant to Southern Regional Education Board for a research project in the area of cerebral palsy, remuneration to be \$50.00 per day plus expenses.
- 3. Mr. F. B. Johnson, Assistant Professor of Architectural Engineering, to act as structural consultant for the firm of Page, Sutherland, and Page.
- 4. Mr. W. A. Cunningham, Professor of Chemical Engineering, to act as consultant to the Humble Oil and Refining Company on a retainer basis, the time required to be one or two days per month.
- 5. Mr. E. F. Gloyna, Associate Professor of Civil Engineering, to act as consultant to the Texas Eastman Company, Longview, requiring him to be absent from the campus about two days in November, total compensation to be about \$200.

Outside and Additional Duties (continued)

- 6. Mr. Kenneth B. Fiske, Instructor in Art, to teach a painting class once a week at Laguna Gloria for the Texas Fine Arts Association, total remuneration to be about \$60.00 per month.
- 7. Mr. Ralph White, Associate Professor of Art, to execute occasional commissions in advertising design and illustration and to conduct a series of six lecture-demonstrations on painting and drawing for a group at Camp Hood, absence from the campus to be about one day a week during November and to mid-December.
- 8. Mr. Virgil E. Barnes of the Bureau of Economic Geology to act as instructor for a group of geological trainees of the Atlantic Refining Company November 10-12, at regular consulting rate.
- 9. Mr. Winston Bode of Radio-Television to accept regular part-time employment on the news staff of KTBC-TV.

WATER LINE AND CONNECTION EASEMENT AND PUMP STATION SITE EASEMENT AT BALCONES RESEARCH CENTER, TRAVIS COUNTY WATER CONTROL & IMPROVEMENT DISTRICT NO. 11
AND THE CITY OF AUSTIN. -- The application for a water connection easement to the City of Austin and Travis County Water Control & Improvement District No. 11 calls for a 14-inch main extension to connect with the University's 12-inch main at the entrance to the Balcones Research Center. The 14-inch main extension will be located at the right-of-way of farm-to-market road 1825 and will be five feet outside the University property. The construction of this 14-inch main extension will be paid for jointly by the City of Austin and the Travis County Water Control & Improvement District No. 11. The application for an easement to allow construction of a small pump station at the extreme northeast corner of the University property at the Balcones Research Center provides that this pump station will be located on the old railroad right-of-way which is now fenced off from the remainder of the University property. The building will be approximately 24 feet x 34 feet. I recommend that the proposed easements be executed after approval as to form by the University Land and Trust Attorney and as to content by the Business Manager, Main University. It is further recommended that the Business Manager, Main University, be authorized to execute the easements for the University in accordance with the usual University stipulations, but without cost to the Travis County Water Control & Improvement District No. 11 and the City of Austin.
