The Budget Dockets prepared by the component institutions listed below are herewith submitted with my recommendation for ratification or approval, as appropriate, at the meeting of the Board of Regents, in El Paso, May 22-23, 1964.

The following changes affecting Central Administration budgetary and fiscal operations are recommended for ratification or approval, as appropriate, by the Board of Regents.

RECOMMENDED AMENDMENTS TO THE 1963-64 CENTRAL ADMINISTRATION BUDGET

Office of the Comptroller

1. Effective April 13, 1964, terminate the employment of Mr. Paul K. Giffin as Clerk-of-the-Works on the Modernization and Remodeling of Five Buildings project (Main University), Mr. Giffin was employed on a month-to-month basis at a monthly salary of \$700, employment to terminate when full-time Clerk-of-the-Works services were no longer needed on this project. (RBC 102)

University Development Board

Transfer \$1,500 from the Publishing and Mailing account to the Maintenance and Operation account. The purpose of the transfer is to cover cost of alteration and remodeling of Development Board Offices. (RBC 100)

Auditing Oil and Gas Production

3. Transfer \$250 from the Clerical Assistants account to the Equipment account. This office is adopting a new system of maintaining title and well records on University Lands, and transferred funds will be used to purchase a typewriter with special type for use on these records. (RBC 103)

CHANGES IN PLANT APPROPRIATIONS AND CONTRACTS

The following item has been recommended by Comptroller Sparenberg and approved by Vice-Chancellor Dolley:

1. Transfer of Funds Between Accounts for Addition to Law School Building at Main University

In connection with the installation of the library bookstacks in the Addition to the Law School Building at the Main University, certain minor changes were found to be necessary which added a small amount to the total of the contract. In order to effect these changes and complete the contract, a change order in the amount of \$472.60 was issued to the Abel Stationers, Contractor for the Library Bookstacks.

It is recommended that the issuance of this change order be approved and that authorization be given for the transfer of \$472,60 from Account No. 85-9059-0099 - Addition to Law School Building - Allotment Account to Account No. 85-9059 -0186 - Addition to Law School Building - Library Bookstack's Contract - The Abel Stationers.

OTHER FISCAL ITEMS

1. Permanent University Fund Bonds, Series 1949

Appropriate \$11,700 from the Available University Fund Unappropriated Balance to an account entitled "Permanent University Fund Bonds, Series 1949, Principal and Interest."

In the 1958 refunding of the 1949 Permanent University Fund Bonds, a deposit in escrow was made with the Texas National Bank of Houston to cover the 1949 bonds outstanding which had not been acquired by the Permanent University Fund. In July, 1963, the Texas National Bank returned the escrow deposit which was credited to the Available University Fund Unappropriated Balance.

The above appropriation is for the purpose of transmitting funds to the Texas National Bank in order that they may clear their account with the Irving Trust Company of New York involving payment of 1949 Permanent University Fund Bonds Numbers 5286 through 5295 plus interest and the called premium.

2. Endowment Office

Appropriate the sum of \$1,200.00 from Account No. 57-0400-0520 - Estate of Lila Belle Etter to a Special Account in the Endowment Office to defray expenses of the Hattie Hewlett Estate, as approved by the Board at its meeting of February 8, 1964 (Minutes, P. 41)

TRUST AND SPECIAL FUNDS - GIFT, BEQUEST AND ESTATE MATTERS. --

BEQUESTS UNDER THE WILL OF DR. JOHN T. HUMPHRIES.—Dr. John T. Humphries of Palestine died on May 23, 1962, leaving a Will providing several bequests to the University. Dr. Humphries received a B.S. in Chemical Engineering in 1922, a M.S. in Chemical Engineering in 1923, and a M.D. in 1927, all from The University of Texas, and was a practicing physician in Palestine for a number of years.

The bequests for the benefit of the University were as follows:

Item of the Will

- (11) To the University of Texas, for the use of the Development Board of Said University, to be applied to benefits for the Department of Engineering, or for the School of Chemistry, or for the School of Physics, or for science research, as they see fit, the sum of Five Thousand Dollars (\$5,000.00).
- (12) To the Students' Loan Fund of the University of Texas, whether it be managed by the Ex-students Association of said University or by the Board of Regents of said University, for the purpose of making loans to students wishing to attend said University, or any of its branches or schools or colleges, but with preference to be given to the Schools of Science, or Engineering, or Medicine, or Chemistry, the sum of Five Thousand Dollars (\$5,000.00); PROVIDED, that, if said Loan Fund is not in need of funds for making loans at the time of the probate of this will, so that the amount bequeathed would lie idle along with other funds for a number of years, then the amount specified herein shall be awarded to the Development Board of the University of Texas for the use of the College of Engineering, or the School of Physics, or the School of Chemistry, or the College of Medicine, as said Board sees fit.
- (13) To the University of Texas, for the use of its Development Board, to be applied to benefits for either or any or all of the Medical Colleges of said University, the sum of Fifteen Thousand Dollars (\$15,000.00)
- (17) To the Alumni Association of the University of Texas Medical School in Galveston, Texas, I bequeath the sum of Two Hundred Forty Dollars (\$240.00)
- (18) To the Alumni Association of the University of Texas, Austin, Texas, (The Main University), I bequeath the sum of Two Hundred Dollars (\$200.00)

Receipts for the bequests have been furnished the Executor, the bequests to the Alumni Associations have been delivered, and the following recommendations are made, all of which have been approved by the Vice Chancellor for Fiscal Affairs and by the Chancellor:

1. That \$3,000 of the bequest under Paragraph 11 of the Will be credited to the Engineering Foundation, with the remaining \$2,000 to a separate account. Dr. Humphries had been a contributor to the Engineering Foundation before his death, and this allocation is in line with approval of the President of the University prior to the receipt of the funds.

- 2. That the \$15,000 bequest be credited to a separate account; and
- 3. That, based on administrative recommendations, the \$5,000 bequest under Paragraph 12 of the Will be credited to a separate account, but not under loan funds, for use under the alternate provisions of the Will.

Recommendations for use of the \$2,000 in item 1 and the other two amounts will be made through appropriate channels.

Ratification of the actions taken above, as well as acceptance of the bequests, is recommended.

TRUST AND SPECIAL FUNDS - REAL ESTATE MATTERS. --

MAIN UNIVERSITY - ARCHER M. HUNTINGTON MUSEUM FUND: PROPOSAL FROM HOUSTON PIPE LINE COMPANY FOR GAS PIPE LINE EASEMENT AND WORK AREA, HUNTING-TON LANDS, GALVESTON COUNTY .-- Houston Pipe Line Company needs to build a new 12-inch gas pipe line from Virginia Point across Galveston Bay to serve Galveston Island. The line will tie into a Southern Union Gas Company line already on the Huntington Lands in the S. C. Bundick Survey and will run a total distance of 5.39 rods on Huntington Lands before entering the Bay. The easement to be granted for so long as the pipe line is used is to be 50 feet wide for construction and thereafter 25 feet wide. In addition to the easement, the company needs a work area of approximately 4.87 acres adjacent to the easement for storing and working pipe for the line in the Bay during the construction. The proposal for the work area is for a lease for 1 year or until the construction work is completed, if the completion is in less than the year. The company will be responsible for all damages to tenants and will restore the ground as nearly as possible to its original state. They offer \$2,000 for the easement and as rental on the work area, and it is recommended that the proposal be accepted and that the Chairman be authorized to execute the appropriate instrument, or instruments, when approved as to form by the Land and Trust Attorney and as to content by the Endowment Officer.

TRUST AND SPECIAL FUNDS - REVENUE BOND MATTERS. ---

MAIN UNIVERSITY: \$1,800,000 BOARD OF REGENTS OF THE UNIVERSITY OF TEXAS STUDENT HOUSING REVENUE BONDS OF 1963 (HHFA PROJECT CH-TEX-121[D]) - BRACKENRIDGE TRACT - REPORT ON DECLARATORY JUDGMENT AND RECOMMENDATION RE SALE AND ISSUANCE OF BONDS. --In line with action of the Board of Regents at previous meetings, the University's petition for a declaratory judgment interpreting the deed from Mr. Geo. W. Brackenridge covering the "Brackenridge Tract" was heard on April 30, 1964, in the 126th District Court of Travis County, and judgment was entered that date holding that the Brackenridge Tract is not a part of the Permanent University Fund. The judgment will become final in 20 days from April 30, 1964, and the University may now proceed with the Married Student Housing project to be constructed on a portion of the tract.

It is recommended that the Endowment Office be authorized to proceed with the remaining necessary steps for the issuance and sale of the bonds covering the project, the dating of the sale of the bonds to be in line with the date of awarding of construction contracts.

The following docket for the Main University is submitted for your approval and submission to the Board of Regents at its meeting in El Paso on May 22 and 23, 1964:

RESEARCH CONTRACTS: The following contracts and amendments have been negotiated by the Office of Government Sponsored Research and have been signed by the Vice-Chancellor for Academic Affairs upon the recommendation of the appropriate Technical Director, the Director of the Office of Government Sponsored Research, and the Business Manager. I recommend your approval and ratification of signatures:

- 1. Contract AF 19(628)-4046, by which the Department of the Air Force, Electronics Systems Division, Air Force Systems Command, Laurence G. Hanscom Field, Bedford, Massachusetts, provides \$39,000.00 for support of conducting Electromagnetic Investigations in the .001 cps to 5 cps region. The contract is effective for the period April 1, 1964 through December 31, 1964, and the research will be performed in the Electrical Engineering Research Laboratory, under the direction of Dr. A. W. Straiton, Ashbel Smith Professor of Electrical Engineering.
- 2. Modification No. 3, Supplemental Agreement to Contract AF 33(657)-10312, by which the Department of the Air Force, Air Force Systems Command, Aeronautical Systems Division, Wright-Patterson Air Force Base, Ohio, adds the sum of \$14,655.00 to the contract funds and extends the period of the contract through May 11, 1964. The work continues in the Military Physics Research Laboratory under the direction of A. E. Lockenvitz, Professor of Physics.
- 3. Modification No. 3, Supplemental Agreement to Contract DA 18-064-AMC-118(A), by which the United States Army Biological Laboratories, Fort Detrick, Frederick, Maryland, substitutes a new "Insurance -- Liability to Third Persons" clause. The new clause does not require the University to procure and cover the contract with Employers Liability and Comprehensive General Insurance. The study of the requirements for the production of interferons from a genetic point of view continues under the direction of Dr. Royce Z. Lockart, Jr., Associate Professor of Microbiology.
- 4. Contract DA 49-129-CIVENG-64-11, by which the Department of the Army, Office of the Chief of Engineers, Washington, D. C., provides \$8,000.00 for support of an Investigation of the Effect of Height upon the Capacity of Bridge Piers Subjected to Horizontal Forces. The contract is effective for the period April 1, 1964 through December 31, 1964, and the research will be performed under the direction of Phil M. Ferguson, Professor of Civil Engineering.
- 5. Modification No. 14, Change Order to Contract N60921-7002, by which the Department of the Navy, U. S. Naval Ordnance Laboratory, White Oak, Silver Spring, Maryland, adds and deletes certain items of Government furnished property to be furnished under the contract. The research continues in the Defense Research Laboratory under the direction of Dr. C. P. Boner, Professor of Physics.

- 6. Contract NObs-90264, by which the Department of the Navy, Bureau of Ships, Washington, D. C., provides \$25,000.00 for a fundamental study of the acoustical source impedance of submarine trim pumps. The contract is effective for the period February 20, 1964 through February 19, 1965, and the research will be performed in the Defense Research Laboratory under the direction of Dr. C. P. Boner, Professor of Physics.
- 7. Amendment No. 1 to Contract Nonr-375(15), by which the Department of the Navy, Office of Naval Research, Washington, D. C., adds the sum of \$12,500.00 to the contract funds and extends the period of the contract through February 28, 1965. The research on Corrosion Reactions and Adsorption Studies continues in the Corrosion Research Laboratory under the direction of Dr. Norman Hackerman, Professor of Chemistry.
- 8. Supplement No. 1 to Grant NsG 432, by which the National Aeronautics and Space Administration, Washington, D. C., adds the sum of \$60,000.00 to the grant funds and extends the period of the grant through March 31, 1965. The research on millimeter wavelength radiation from solar bodies continues in the Electrical Engineering Research Laboratory under the direction of C. W. Tolbert and A. W. Straiton.
- 9. Grant NsG 604, by which the National Aeronautics and Space Administration, Washington, D. C., provides \$50,000.00 for support of an investigation of soil modeling problems related to impact studies. The grant is effective for the period April 1, 1964 through March 31, 1965, and the research will be performed under the direction of Dr. Lymon C. Reese, Associate Professor of Civil Engineering.
- 10. Extension to Training Grant No. 33, dated March 17, 1964, by which the United States Department of Health, Education, and Welfare, Welfare Administration, Children's Bureau, adds the sum of \$39,875.00 and extends the period of the grant through June 30, 1965. The child welfare training program continues under the direction of Professor Anne Wilkens, Graduate School of Social Work.
- 11. Contract PH 43-64-557, by which the United States Department of Health, Education, and Welfare, Public Health Service, provides \$113,132.00 for support of research entitled "The Effects of Plastic Devices on Biological Products." The contract is effective for the period March 30, 1964 through March 29, 1965, and the research will be performed under the direction of Dr. John Autian, Associate Professor of Pharmacy.
- 12. Grant GM-11111-02, by which the United States Department of Health, Education, and Welfare, Public Health Service, provides \$51,125.00 for support of research entitled "Biochemical Systematic Studies in the Genus Baptisia." The grant is effective for the period May 1, 1964 through April 30, 1965, and the research will be performed under the direction of Dr. R. E. Alston, Associate Professor of Botany; Dr. T. J. Mabry, Assistant Professor of Botany; and Dr. B. L. Turner, Professor of Botany.
- 13. Grant HD 00950-02, formerly MH 07471-01, by which the United States Department of Health, Education, and Welfare, Public Health Service, provides \$14,050.00 for support of research entitled "Investigation of the Basic Conditioning Process." The grant is effective for the period May 1, 1964 through April 30, 1965, and the research will be performed under the direction of Dr. John Milton Theios, Assistant Professor of Psychology.
- 14. Grant GB-2147, by which the National Science Foundation, Washington, D. C., provides \$15,700.00 for modification of the University's research boat Vagabond. The grant is effective for the period March 19, 1964 through March 18, 1965, and the program will be directed by Dr. Patrick L. Parker, Institute of Marine Science.

- 15. Grant GE-4699, by which the National Science Foundation, Washington, D. C., provides \$3,670.00 for support of an "In-Service Institute in Chemistry for Secondary School Teachers." The grant is effective for the period March 27, 1964 through February 28, 1965, and the program will be under the direction of Dr. Jefferson C. Davis, Assistant Professor of Chemistry.
- 16. Grant GF-152, by which the National Science Foundation, Washington, D. C., provides \$8,400.00 for support of research entitled "Relationships Between Endemic Hawaiian Drosophilidae and Japanese Drosophilidae." The grant is effective for the period April 15, 1964 through October 14, 1966, and the research will be performed under the direction of Dr. Marshall R. Wheeler, Professor of Zoology, and Dr. Wilson S. Stone, Professor of Zoology.
- 17. Grant GP-2596, by which the National Science Foundation, Washington, D. C., provides \$74,800.00 for support of research entitled "Radar Studies of the Atmosphere." The grant is effective for the period March 1, 1964 through February 28, 1966, and the research will be conducted in the Electrical Engineering Research Laboratory under the direction of Dr. Alfred H. LaGrone, Professor of Electrical Engineering, and Dr. A. W. Straiton, Ashbel Smith Professor of Electrical Engineering.
- 18. Grant GP-2724, by which the National Science Foundation, Washington, D. C., provides \$49,400.00 for support of research entitled "Threshold Logic." The grant is effective for the period April 1, 1964 through March 31, 1966, and the research will be performed under the direction of Dr. Clarence L. Coates, Professor of Electrical Engineering.
- 19. Grant GP-2728, by which the National Science Foundation, Washington, D. C., provides \$23,800.00 for support of "Investigations of Radio Frequency Plasmas." The grant is effective for the period April 15, 1964 through April 14, 1966, and the research will be performed under the direction of Dr. Hans Schlüter, Associate Professor of Physics.
- 20. Grant GP-2762, by which the National Science Foundation, Washington, D. C., provides the sum of \$35,800.00 for support of research entitled "Interaction of Nitrosylruthenium Compounds with Particulates in an Aquatic Environment." The grant is effective for the period April 15, 1964 through April 14, 1966, and the research will be performed under the direction of Dr. Earnest F. Gloyna, Professor of Civil Engineering.
- 21. Subcontract No. 181471, by which the Applied Physics Laboratory, Johns Hopkins University, Silver Spring, Maryland, provides \$30,000.00 for support of certain radar studies. The subcontract is effective for the period March 3, 1964 through September 30, 1964, and the research will be performed in the Defense Research Laboratory under the direction of Dr. C. P. Boner, Professor of Physics.
- 22. Amendment No. 1 to Subcontract No. 181471, by which the Applied Physics Laboratory, Johns Hopkins University, Silver Spring, Maryland, adds Task B and the sum of \$50,000.00 to the contract funds to conduct a study of the effects of ionospheric refraction on satellite doppler tracking data. The research will be performed in the Defense Research Laboratory under the direction of Dr. C. P. Boner, Professor of Physics.
- 23. Change Order No. 2 to Purchase Order 13-6587, by which the Sandia Corporation, Albuquerque, New Mexico, revises the report requirements under the contract. The research entitled "Piston and Cylinder Vibration Study" continues under the direction of Dr. Lyle G. Clark, Professor of Mechanical Engineering.

ACADEMIC CONTRACTS: The following contracts have been executed at the Main University by the official indicated. I recommend approval and ratification of signatures:

- 1. Agreement No. DA 41-133 AIV-5196 with the Department of Army, signed by Business Manager James H. Colvin, whereby the University through its Petroleum Training Department, Industrial and Business Training Bureau, Division of Extension, will provide training for military personnel of the Army during the period April 1964 April 1965, payment for the course of instruction to be set out in the order covering the enrollment, the cost to be no greater than that charged for other students pursuing the same or a similar curriculum.
- 2. Agreement with Air Force, signed by Business Manager James H. Colvin, which relieves the University from custodial responsibility for Air Force equipment by cancellation of the bond between the Air Force and University, dated January 15, 1962, and transfers this responsibility to the properly appointed Property Officer of the United States Air Force.
- 3. Letter agreement with American Petroleum Institute, signed by Chancellor Harry Ransom, whereby the sum of \$10,000 is made available to continue during the period July 1, 1964 June 30, 1965, research on a project entitled "Solid-Fluid Interactions as Related to Petroleum Production." The investigation is API Research Project 47d, under the direction of Dr. Norman Hackerman.
- 4. Interagency Contract No. 4413-933, with the Texas State Department of Health, signed by Vice-Chancellor Norman Hackerman and Business Manager James H. Colvin, whereby the University will make available for consulting purposes to the Department of Health the services of Dr. Gideon Sjoberg, Associate Professor of Sociology, for no more than five days during the months of April, May, and June, 1964, the total amount to be paid for said services not to exceed \$400.00.
- 5. Interagency Contract No. 4413-935 with the Texas State Department of Health, signed by Vice-Chancellor Norman Hackerman, whereby the Health Department will furnish an amount not exceeding \$500 for the current fiscal year for travel expenses (transportation and per diem) for employees or officials of the University to carry out activities of the Mental Health Planning Committee.

FACULTY LEGISLATION: I recommend approval of the following faculty legislation passed by the General Faculty and/or Faculty Council:

- 1. The Faculty Council on April 10, 1964, approved by the circularization procedure the catalogue changes in the College of Arts and Sciences (D&P 3315-3317) as follows:
- (a) Under Plan I for the Degree of Bachelor of Arts with a major in Government, in both First Minor and Second Minor, a rearranging of the permitted subjects in such a way that, in the opinion of the Departmental Committee on Undergraduate Majors in Government more flexibility will be introduced into the departmental program and thus meet the needs of certain students who are anticipating further work in law, elementary and secondary education, and journalism.
- (b) The establishment of Interdepartmental programs in Middle Eastern Studies and in Asian Studies, subject to existing degree requirements and consistent with the Major-Minor programs now in operation for the degree of Bachelor of Arts, Plan I, as set forth in the College of Arts and Sciences Catalogue for 1963-65, pages 45-58.

There has been an expansion of course offerings, including language and linguistics, into the less traditional non-western areas, and there is growing student interest in the study of such areas. The authorization of these programs will help to focus attention on the opportunities in these fields at the University. Faculty committees supervising such programs will assist students in the choice and concentration of courses in order to develop the proper background, and so that undergraduate programs will represent proper preparation for graduate study or employment opportunities in these fields. No new department or degree is contemplated, but rather a collection of catalogue courses (and a senior seminar) -- offering some choice and flexibility -- to form an interdepartmental program.

(c) On pages 49, 50, 51, 52, 53, and 57 of the Arts and Sciences Catalogue under Requirements for the Degree of Bachelor of Arts, Plan I, under C. Majors and Minors under Anthropology, Economics, Geography, Government, History, and Sociology, add under the First Minor for each, International Studies (see page 53).

On page 53 change the requirements in the International Studies program by requiring a major in specific fields (viz., Anthropology, Economics, Geography, Government, History, or Sociology) with an eighteen hour minor in International Studies for the usual departmental first and second minor requirements.

The creation of an International Studies minor will provide participating students with more specific focus for their efforts and interests. The minor will allow some choice and flexibility, but will require eighteen hours of advanced courses with international content in at least three departments other than the major department. Such an interdepartmental spread for students with international interests is preferable to the existing minors requirements. The proposal represents a modification of an existing program and an adjustment in the Minor requirements of certain departments; no new degree or department is contemplated. The facilities of the six departments named have approved and support this request for an International Studies minor.

(d) On page 50 of the Catalogue under Requirements for the Degree of Bachelor of Arts, Plan I, under Majors and Minors, substitute the following:

A student may enter the Eastern European program only with the consent of the Chairman of the Committee on Eastern European Studies and will plan his schedule with an adviser to whom he will be assigned by the Chairman. A student in the program must satisfy the requirements of a major in Economics, Geography, Government, History, or with the consent of the Committee, in another appropriate field of study. A student must complete an Eastern European concentration including I. S. 360 and eight other courses from a list prescribed by the Committee on Eastern European Studies. Courses in the major and minor departments required for the concentration will also count toward the major and minor requirements.

The program requires a minimum of six semester hours of foreign language (Russian, Czech, or another Eastern European language) beyond the sophomore level. A student should consult with the Chairman about this requirement.

This re-statement of the program omits a listing of specific course numbers, although there is no intention to reduce the scope or course hour requirements of the program. In view of the frequent deletion of or addition to the catalogue course offerings, it is desirable that the Committee be able to make substitutions so as to adjust a student's program to current offerings.

- (e) On page 57 of the Catalogue under Requirements for the Degree of Bachelor of Arts, Plan I, Majors and Minors under Speech, add to the list of possible minors, Education, which was inadvertently omitted. Since the majority of Speech majors plan to teach speech either as classroom teachers in the secondary schools or as speech and hearing therapists at all levels, they need certification. This requires them to take a sequence of courses in professional education totalling from 18 to 27 semester hours. It seems appropriate, therefore, that such students should be allowed to use this concentration in education as the minor.
- The Faculty Council on April 10, 1964, approved by the circularization procedure the recommendations of the School of Law providing a substitution for the Code for Student Control of Law Examinations on pages 54 and 55 of the Catalogue, to provide a more comprehensive code of conduct on the part of law students, the present code being restricted completely to the taking of examinations. The new code has a much broader scope, covering questions concerning examination security, plagiarism, taking examinations for another, unauthorized removal of examination questions from the examination room, etc. The new code covers types of scholastic dishonesty that could arise in the School of Law not now covered. With the tremendous increase in the School of Law enrollment in recent years, the number of cases of scholastic dishonesty have increased. The present Honor Code as a guide for conduct has probably always been deficient, but its rare use did not bring its inadequacies into focus until recent years.

The new code also provides better protection for the rights of an accused. Under the present system, all hearings are in the hands of the students with the faculty having an observer. Consequently, procedures, hearings, and trials have varied greatly over the years. The new code provides for two faculty members and three students on the Honor tribunal. The faculty members will give continuity to the system, and also will provide maturity in the consideration of cases.

This legislation is reported on pages 3304-3314 of the Documents and Proceedings of the Faculty Council.

3. The Faculty Council on April 22, 1964, approved by the circularization procedure the recommendations of the College of Education (D&P 3323-3325) as follows:

In the Catalogue for 1962-64 some minor changes are recommended to correct titles of degrees, clarify student responsibility, to delete requirements no longer needed, to raise grade point requirements for enrolling for student teaching, and to make changes in regard to teacher certification.

TRAVEL PAID FROM NON-TRAVEL FUNDS: The following trips have been made with expenses paid from accounts not specifically designated for travel:

- 1. Mr. Wallace Mendelson, Professor of Government, April 30 May 11, 1964, to New York City, to do some research, transportation expenses to be paid from excellence funds assigned to the Departmental Program Development for Government.
- 2. Mr. Derek S. Hoare, Assistant Professor of Microbiology, May 2-7, 1964, to Washington, D. C., to attend the national meeting of the American Society for Microbiology and present a paper, expenses to be paid from Excellence Fund assigned for Departmental Program Development for Microbiology.

Travel from non-travel funds (continued)

3. Mr. Alexander L. Clark, Assistant Professor of Sociology, May 6-9, 1964, to Norman, Oklahoma, to examine the Human Relations Area file for research suitability, expenses to be paid from University Research Institute Grant.

<u>USE OF TEXTBOOKS</u> <u>WRITTEN BY FACULTY:</u> I recommend the use as textbooks of the following written by members of the faculty:

1. Spectrum, a reader of contemporary German materials, by Lehmann, Rehder, and Beyer, both Professors of Germanic Languages, which sells for approximately \$6.00 with 15% royalty to authors. The book will be used in the Summer of 1964.

GIFTS AND GRANTS TO THE MAIN UNIVERSITY

SALE OF UNIVERSITY PROPERTY: This item is submitted in accordance with Part Two, Chapter VII, Section 10, of the Regents' Rules and Regulations which provides for the disposal of University property, and specifically with section 10.5 which provides that sales in amount of \$1,000 or more shall be approved in advance by the Board of Regents.

About four years ago the Bureau of Engineering Research acquired a second-hand LGP-30 Computer complete with high speed paper tape reader and punch and a Friden Off-Line Flexowriter. The College of Engineering has now acquired an IBM 1620 and the auxiliary equipment, which is a much more modern computer. Therefore the LGP-30 is seldom used.

The LGP-30 computer and accessories were offered for sale both within the Main University and at Texas Western College. No takers were found within the University System so the equipment was advertised for sealed-bid sale. Advertisements were placed in the American Statesman, the Houston Chronicle, and the Dallas Morning News. Only one bid was received and that was from Bishop Associates, 1627 Main Street, Kansas City, Missouri, in the amount of \$4,500.

Dr. W. A. Cunningham, Associate Director of the Bureau of Engineering Research, and Dr. J. J. McKetta, Dean of the College of Engineering, both recommend that this bid be accepted, and that the proceeds of the sale be credited to the Bureau of Engineering Research. Business Manager Colvin and I concur in this recommendation and request your approval for such sale.

STANLEY WALKER MEMORIAL AWARD FOR CREATIVE REPORTING: A committee of Austin citizens organized in the Fall of 1963 to establish a Stanley Walker Memorial Award has submitted to the University approximately \$1,500 which has been deposited in an account entitled Stanley Walker Memorial Award in Journalism. Out of this fund an award is to be made each spring to the journalism student who is considered by the judges to have written the best news or feature article, an article which may have appeared in the Daily Texan or another publication, but printing is not a prerequisite for consideration. The contest committee will consist of the Director of the School of Journalism, the chairman of the Stanley Walker Memorial Award Committee, and a third member selected by these two. The Memorial Award Committee wishes the money placed in a fixed income investment, and the interest or income used for the yearly award of \$50, except that this amount the first year will be taken from the funds collected. Whenever possible, the Director of the School of Journalism, with the consent of the Board of Grantors of the Journalism Development Funds, may arrange for a matching grant to increase the amount of the award to the winning student.
