Boner, providing for the Texas Nuclear Corporation of Austin to use the machine at the rate of \$50.00 per hour, the minimum number of hours to be 100 and the maximum 600.

RESEARCH CONTRACTS: The following contracts and amendments have been negotiated by the Office of Government Sponsored Research and have been signed by the Vice-President upon the recommendation of the appropriate Technical Director, the Director of the Office of Government Sponsored Research, and the Business Manager. The research continues under the direction of Dr. M. Y. Colby, Professor of Physics, and Executive Director, Military Physics Research Laboratory.
- 2. Letter Contract AF 41(657)-149, by which the Department of the Air Force, Air Research and Development Command, provides \$63,982.00 for research on the biological effects of ionizing radiation in various species, and protection of personnel against radiation. The contract is effective for the period March 5, 1957 until such time as the funds are expended, and the research is to be performed under the direction of Dr. T. S. Painter, Professor of Zoology, and Director of the Radiobiological Laboratory.
- 3. Supplemental Agreement No. 11 to Contract AF 18(600)-165, by which the Department of the Air Force, Air Research and Development Command, extends the contract period through March 31, 1957, without additional funds. The research continues in the Radiobiological Laboratory under the direction of Dr. T. S. Painter, Professor of Zoology, and Director of the Laboratory.
- 4. Contract AF 19(604)-2249, by which the Department of the Air Force, Air Research and Development Command, provides \$30,000.00 for research on tropospheric propagation. The contract is effective for the period March 1, 1957 through February 28, 1958, and the research is to be performed under the direction of Dr. A. W. Straiton, Professor of Electrical Engineering and Director, Electrical Engineering Research Laboratory.
- 5. Change Order No. 7 to Contract AF 33(616)-2290, by which the Department of the Air Force, Air Research and Development Command, extends the contract period through June 30, 1957, without additional funds. The research continues under the direction of Dr. C. P. Boner, Professor of Physics and Director, Defense Research Laboratory.
- 6. Supplemental Agreement No. 7 to Contract AF 33(616)-2423, by which the Department of the Air Force, Air Research and Development Command, extends the period of the contract through April 1, 1957, without additional funds. The research on development of recording microwave refractometers continues under the direction of Dr. A. W. Straiton, Professor of Electrical Engineering, and Director, Electrical Engineering Research Laboratory.
- 7. Supplemental Agreement No. 8 to Contract AF 33(616)-2423, by which the Department of the Air Force, Air Research and Development Command, adds the sum of \$5,000.00 to the contract funds, and amends the scope of the work. The research on development of recording microwave refractometers continues under the direction of Dr. A. W. Straiton, Professor of Electrical Engineering, and Director, Electrical Engineering Research Laboratory.

- 8. Change Order No. 9 to Contract AF 33(616)-2423, by which the Department of the Air Force, Air Research and Development Command, extends the period of the contract through May 31, 1957, without additional funds. The microwave studies continue under the direction of Dr. A. W. Straiton, Professor of Electrical Engineering and Director, Electrical Engineering Research Laboratory.
- 9. Change Order No. 3 to Contract AF 33(616)-2842, by which the Department of the Air Force, Air Research and Development Command, extends the period of the contract through April 30, 1957, without additional funds. The research continues under the direction of Dr. A. W. Straiton, Professor of Electrical Engineering and Director, Electrical Engineering Research Laboratory.
- 10. Contract AF 33(616)-3985, by which the Department of the Air Force, Air Research and Development Command, provides \$299,961.36 for research on air-to-air combat analysis. The contract is effective for the period March 1, 1957 through February 28, 1958 and the research is to be performed under the direction of Dr. M. Y. Colby, Professor of Physics and Executive Director, Military Physics Research Laboratory.
- 11. Contract AF 33(616)-5024, by which the Department of the Air Force, Air Research and Development Command, provides \$40,000.00 for research on radio propagation and associated refractive index problems. The contract is effective for the period April 1, 1957 through March 31, 1958, and the research is to be performed under the direction of Dr. A. W. Straiton, Professor of Electrical Engineering and Director, Electrical Engineering Research Laboratory.
- 12. Supplemental Agreement No. 1 to Contract AF 33(604)-14198, by which the Department of the Air Force, Air Materiel Command extends the period of the contract to August 6, 1957, without additional funds. The research continues in the Defense Research Laboratory under the direction of Dr. C. P. Boner, Professor of Physics, and Director of the Laboratory.
- 13. Supplemental Agreement No. 13 to Contract AF 33(600)-22582, by which the Department of the Air Force, Air Research and Development Command, incorporates into the contract the fixed overhead rate of 38.30% of Defense Research Laboratory Salaries and Wages for the period January 1, 1955 through December 31, 1955 and the fixed overhead rate of 35.50% of Defense Research Laboratory Salaries and Wages for the period January 1, 1956 through August 31, 1956. The research continues under the direction of Dr. C. P. Boner, Professor of Physics and Director, Defense Research Laboratory.
- 14. Modification No. 1 to Contract DA19-129-QM-817, by which the Department of the Army, Quartermaster Research and Development Command, provides for the furnishing of a 10-Ton Fruehauf Refrigerated Trailer as government furnished property for use under the contract. The research on development and evaluation of high velocity impact energy dissipators continues under the direction of J. Neils Thompson, Professor of Civil Engineering and Director, Structural Mechanics Research Laboratory.
- 15. Modification No. 3 to Contract DA-44-009 ENG-2566, by which the Department of the Army, Engineer Research and Development Laboratories, extends the period of the contract through July 31, 1957, without additional funds. The research continues in the Defense Research Laboratory under the direction of Dr. C. P. Boner, Professor of Physics, and Director of the Laboratory.

- 16. Amendment No. 10 to Contract Nonr-375(00), by which the Department of the Navy, Office of Naval Research, incorporates into the contract the latest "Negotiated Overhead Rates" Clause and reduces the amount to be withheld from reimbursement, until compliance with the Patent Rights Clause, from 10% of the contract amount to 1%.
- 17. Amendment No. 1 to Contract Nonr-375(07), by which the Department of the Navy, Office of Naval Research, adds the sum of \$25,000.00 to the contract funds, and extends the period of the contract through April 30, 1958. The research on the study of specialized millimeter propagation measurements is under the direction of Dr. A. W. Straiton, Professor of Electrical Engineering and Director, Electrical Engineering Research Laboratory.
- 18. The research on critical properties of some organic compounds continues under the direction of Dr. Kenneth A. Kobe, Professor of Chemical Engineering.

24. Grant NSF-G3637, by which the National Science Foundation, provides \$1,500.00 for support of research entitled spectro-photometric analysis of procyon. The grant is effective for the period May 1, 1957 through May 31, 1958, and the research is to be performed under the direction of Dr. Frank N. Edmonds, Jr., Assistant Professor of Mathematics and Astronomy.

The recommendations were approved by the College of Fine Arts at its regular meeting on March 4, 1957. The Secretary has classified these recommendations of exclusive application and primary interest only to a single school or college.

Notice is hereby given that this legislation will be presented to the Board of Regents for adoption unless a signed protest, with reasons, is received by the Secretary of the Faculty Council from a member of the Council within five days of the date of this publication. If a protest is received, the proposed legislation will be presented to the Faculty Council for action at its meeting of March 18, 1957.

RECOMMENDATIONS OF THE COLLEGE OF FINE ARTS

Department of Art

1. On page 21 under "Requirements for the degree of Bachelor of Fine Arts, Plan I, for students Majoring in Art", in the fourth line change the word "six" to the word "three" and insert after the words "social sciences", "six semester hours in science, mathematics, or foreign language." In the sixth line change the word "twelve" to the word "eighteen"; and after 308 add "and six semester hours of advanced art history." In the seventh line change the word "eighteen" to the word "nine."

Reasons: To conform to the "Graham Committee" report as adopted by the General Faculty and to provide a comparable background in art history to that now given the Art Education majors.

2. On page 22 under "Plan II, for Students Majoring in Art Education" correct lines 8, 9, and 10 to read, "Thirty-nine semester hours outside the Department of Art, including English 601, History 315% and 315%, Government 610; three semester hours of social science; six semester hours of science; six semester hours of foreign language; Drama 314; Music 302%." In line 12 change number "122" to number "129."

Reasons: To conform to the 'Graham Committee' report as adopted by the General Faculty and to the proposals of the Texas Education Agency.

Department of Drama

1. Add Drama 219 and 219M as a requirement for all drama majors.

Reason: To award proper credit for sophomore rehearsal and performance activities.

2. Delete Drama 327 as a requirement for drama majors concentrating in acting.

Reason: To decrease the number of required performance hours.

3. Add for all drama majors: three additional semester hours in social science, and six semester hours in mathematics, natural science, or foreign language, and three semester hours in the area of Art and Literature.

Reason: To conform to the "Graham Committee" report as adopted by the General Faculty.

- 4. On page 24 under Droma Education
 - (a) Add Drama 371K and 371L as alternate course requirements for Drama 361J and 361K.

Reason: To provide students an opportunity to work in the area of period play production.

(b) Substitute Educational Psychology 320K for Curriculum and Instruction 361T, and permit a selection of three semester hours from Curriculum and Instruction 320L, 361J or 370Q.

Reason: To conform to action taken by the University Council on Teacher Education.

Department of Music

1. Change all Bachelor of Music degree programs to include three additional semester hours of social science, and six semester hours in mathematics, natural science, or foreign language.

Reason: To conform to the "Graham Committee" report as adopted by the General Faculty.

2. Delete Music 403L and replace with 303L in all music degree programs.

Add Music 313L, Historical Survey of Music Literature (a new course) to all music degree programs except Music Education. (Music Education majors may substitute 313L or 330J at the discretion of the advisor.)

Reason: To provide for a better distribution of music literature courses.

3. (a) On page 31, first paragraph under Major in Voice - delete Voice 460.

Recson: To provide a comparable course arrangement for Voice pedagogy majors viz. other pedagogy requirements.

(b) On page 32, first paragraph, add 370 as an alternate course with 372 and 377.

Reason: To provide greater choice in advanced music literature electives.

4. On page 38, first paragraph, add Mus 274J and 274K as alternate courses for 273J and 273K.

Reason: To provide greater choice in advanced music literature electives.

5. On page 39, second paragraph, add Mus 261K as an alternate course to 375.

Reason: To provide greater choice in advanced music literature and theory courses.

- 6. Proposed changes in Music Education curriculum
 - (a) Reduce number of curricula from four to three.

Reason: This is the certificate recommended by the Texas Education Agency for special subjects.

(b) Reduce voice principal requirement to completion of 420b.

Reason: To correspond with the piono requirement.

(c) For instrumentalists change Music 210K7 and 210K9 to 210K7 or 210K9, and 210K1 and 210K8 to 210K1 or 210K8.

Reason: To reduce the number of required courses.

(d) Change Music 269K from required to elective, and to read 269K or 369K.

Reason: To reduce the number of Professional courses.

(c) Consolidate the material in Music 272M and 258K to 372M.

Reason: To reduce the number of courses in Professional Education.

(f) On page 45, the Music Education Nine Semester Curriculum (140 semester hours) should be changed so as to include courses as follows:

- In addition to the Four Year Curriculum (as altered) -- (1) Add (for Voice and Piano Principals) 269K, 200.1, 200.4 or 10, Music 262, and 4 hours free elective - - total addition, 12 hours.
- (2) Add (for Band and Orchestra Principals) 225L, 262, 200.4 and 10, 210Kl and 8 or 210K7 and 9, and 4 hours free elective - - total addition, 12 hours.

Reason: To provide a broader program for music education majors.

7. On page 53, under Degree of Bachelor of Science in Music add completion of Prin. Instr. 401 and add Princ. Instr. 410 as an alternate to 4 of the advanced hours in theory or literature. If the Prin. Instr. is not piano the proficiency of Mus. 210K.5 is required.

Reason: To provide more opportunity for Applied Music in line with nationally established standards for this degree.

RECOMMENDATIONS OF THE FACULTY COUNCIL

On Page 8 of the 1954-56 School of Architecture Catalogue, under "Registration for Advanced Professional Courses," make the following changes:

1. Change: The first sentence, first paragraph, to read:

"In order to register for advanced professional courses in the third and fifth years, a student must have completed all of the work prescribed for the preceding years with the exception of electives."

Reason: In order that correlated subjects may not become disassociated with resulting difficulty for the student.

2. Change: The second sentence, first paragraph, to read:

"His grade average on all courses undertaken in this University, whether passed or failed, must be at least C, computed in accordance with the scoring plan indicated in the section on scoring in the General Information Bulletin."

Reason: As previously worded, a student having failed one or more courses could, by repeating and subsequently passing them, acquire a grade point standing higher than a student who had passed the subject the first time

3. Delete third sentence, first paragraph. Fourth sentence, first paragraph, to remain unchanged.

On Page 10, first line of the Catalogue under "Hours of Work of Employed Students," after the word, "employment," add the words "and comply with the Students," after the word, "employment," add to Board of Regents' rule on maximum work loads."

Reason: This will help to correct an existing situation in which students generally endeavor to carry excessive outside employment to the detriment of their scholastic work.

Page 10: Under "Requirements for the Bachelor of Architecture Degree," delete the first three paragraphs and first sentence of the fourth paragraph and insert instead:

"The candidate for a Bachelor's Degree in Architecture must complete the subjects required for that degree in the order set forth in the plan for that degree, whether he begins his work in the summer or in the long session."

The last two sentences are to remain unchanged.

Reason: The Bachelor's Degree in Planning has been dropped.

Pages 11 and 12: Delete the words "PLAN I Leading to the Degree of Bachelor of Architecture" and substitute instead the words "The Bachelor of Architecture Degree." Under the headings "FRESHMAN YEAR, SOPHOMORE YEAR, JUNIOR YEAR, SENIOR YEAR, FIFTH YEAR and SUMMARY," substitute the following material:

The following changes have been made:

1. Change: Restore to the curriculum a 6 semester credit course in nonobjective, Basic Design, Arc. 607.

Reason: It has been demonstrated that where students have had instruction in basic, non-objective design, they are more able to cope successfully with the problems of creative design and make better progress in the advanced courses in design.

2. Change: Drop Mechanical Drawing 208.

Reason: Most schools of architecture have abandoned specific courses in mechanical drawing, it having been demonstrated that skill in such techniques may be developed in the courses requiring that skill.

3. Change: Replace the second scmester elective with basic design.

Reason: In order to present a strong course in basic design, two semesters of work in this field are desirable.

NOTE: The credit structure will change from 16-17 to 17-17.

1. Change: Reduce Architecture 510K and 510L from a five (5) semester credit course to four (4) semester credits, Architecture 410K and 410L.

Reason: With the introduction to design in the first year, this course may be reduced in class time with no reduction in effectiveness.

2. Change: Move Ar. E. 315 (Electrical Equipment and Illumination for Architects) to 4th year and combine with M.E. 327 (Heating and Ventilation) and Ar. E. 245Q (Building Sanitation) in one subject "Mechanical Equipment of Buildings," with an architectural coordination approach.

Reason: It is not the architect's basic function to design and calculate the multiplicity of mechanical equipment necessary in large contemporary structures, but it is his function to specify types of systems and end results to be achieved and to coordinate the proper inclusion of such equipment. The courses should be designed with this in mind. The architect should, of course, be competent in handling all small installations in these fields.

3. Change: Change titles to Arc. 215K and Arc. 215L from "Building Construction I" and "Building Construction II" respectively.

Reason: In order to establish a continuity in the structural areas parallel with the design courses.

4. Change: Drop C.E. 113, Testing Laboratory.

Reason: Most Schools of Architecture do not include such a course. It is sufficient for the architect to know how and where to obtain such tests and to evaluate the results for his purposes.

5. Change: Move C.E. 216, Surveying, to 3rd year.

Reason: To balance the curriculum.

6. Change: Replace E. 317, Writing for Engineers, with E. 318, American Literature. (See also acceptable elective English and Speech courses in 3rd year notes.)

Reason: A strengthened command of English is important to the professional man.

7. Change: Move U.S. History from 4th to 2nd year.

Reason: This subject is a normal sophomore subject and is now so scheduled. NOTE: Credit structure changed from 18-18 to 17-17.

At this point, in order to register for advanced professional courses, a student must have completed all work prescribed for the preceding two years with the exception of electives.
