Dear Francie:

Section 55.03 (a), Texas Education Code provides that the Board of Regents of each institution of higher education shall make a good faith effort to award to minority and woman-owned businesses (MWBE) 25 percent of total contract costs relating to the issuance of bonds under Chapter 55 and 25 percent of total contract costs relating to items to be financed by such bond proceeds.

In Academic Year (AY) 2022-23, 12 contracts funded with RFS or CCAP were with MWBEs representing \$2.7 million (.83%) of the total cost of contracts. There were 154 contracts with firms not minority or woman-owned with costs of \$322.9 million. In addition, there were \$70.1 million of payments to MWBE subcontractors on projects with RFS or CCAP funding.

On contracts related to the issuance of bonds, 3 of the 7 underwriters were MWBEs and expenditures for the contracts were 18 percent of the total underwriting expenditures. In addition, a WBE firm provided printing under contracts relating to the costs of issuance. Overall 12 percent of the costs for issuance and underwriting was spent with MWBE firms.

Enclosed is the report required by Section 55.03 (b). Section 1 contains summary of systemwide payment information regarding contracts related to the issuance of bonds and bid information, Section 2 provides contract payments for prime firms for each institution, Section 3 provides MWE payment information, and Section 4 provides information on the firms used and cost related to the issuance of the bonds.


