7 meanings

I didn't say she stole my money - someone else said it.

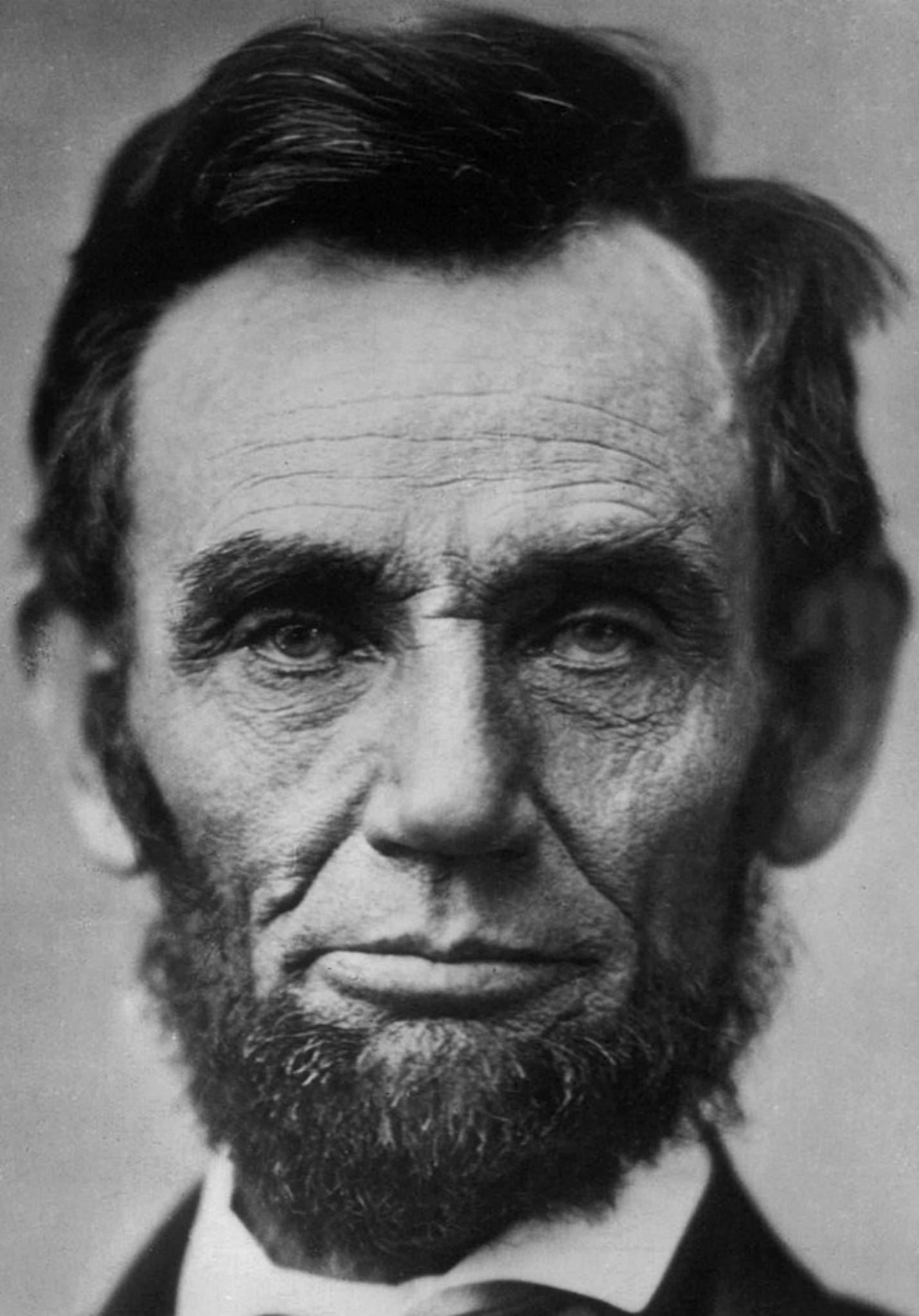
